# (iii) e-tender processing fee minimum of Rs. 590/- (non refundable), shall be payable to M/s. ITI Limited, through their e-gateway by credit / debit card, internet banking or RGTS / NEFT facility.

## **SECTION - II**

### **Instructions to Bidders**

#### 1. Services to be provided

1. Services to be provided are given in section VI.

#### 2. Eligibility Conditions

- a) The bidder should have required vehicle(s) of model not older than year **2015**. Vehicles registered as commercial vehicles in their name(s) or Firm's name or bidder should produce affidavit for leased vehicle for use as commercial vehicles.
- (b) The bidder shall have experience of similar type of contract of supplying minimum one commercial Vehicle to Govt. Organization / any public sector undertaking /reputed private companies.
- (c) The bidder shall be registered with concerned Department of Govt. of HP / Govt. of India for GST or the bidder shall submit an affidavit declaring that the annual income from the hiring of commercial vehicle does not exceed the limit fixed by concerned Department of Govt. of HP / Govt. of India.

#### 3. Cost of Bidder

The bidders shall bear all costs associated with the preparation and submission of the bid. BSNL in no case be responsible for these costs regardless of the conduct or outcome of the bidding process.

#### 4. Bid Document

- 4.1 Bid document includes

  - b. Instruction to bidders

4.2 The bidder is expected to examine all instructions, forms, terms and specifications in the Bid Documents. Failure to furnish all the information required as per Bid Documents or submission of the bids not substantially responsive to the Bid Documents in every respect will be at the bidder's risk and may result in rejection of the Bid.

#### 5. AMENDMENT TO BID DOCUMENT

- (i) At any time, prior to the date of submission of bid, BSNL may, for any reason whether at its own initiative or in response to a clarification required by a prospective bidder, modify the bid documents by amendments.
- (ii) The amendments shall be notified in writing to all prospective bidders on the address given at the time of purchase of the Bid Document and these amendments will be binding on them.

#### 6. DOCUMENTS COMPRISING THE BID

The bid prepared by the bidder shall comprise the following components

- Documentary evidence established in accordance with clause1 that the bidder is eligible to bid and is qualified to perform the contract if his bid is accepted.
- b. EMD furnished is in accordance with clause -9.
- c. Bid Form and price schedule completed in accordance with clause 6.
- d. Partnership Deed or proprietorship deed or Articles / Memorandum of Association or affidavit in respect of leased vehicle as the case may be.
- e. The bidder shall furnish the particulars of his past performance with PSUs / Government agencies / private companies..
- f. Certificate in r/o Non-participation of any close relative as per section XII in Section in bid forms.
- g. A clause by clause compliance as per clause 10.
- h. Letter of authorization for attending bid opening in form section X.
- i GST registration number or an affidavit declaring that the annual income from the hiring of commercial vehicle does not exceed the limit fixed by concerned Department of Govt. of HP / Govt. of India.
- j PAN Number (Permanent Account Number).

#### 7. BID FORM

The bidder shall complete the Bid Form as per Section VI, VII & VIII in the bid document covering the services to be rendered.

#### 8. PRICE BID.

- (i) The supplier shall quote his rates in the Financial/Price bid online in Excel Work Sheet on www.tenderwizard.com/BSNL]. [The financial bid as given under Section VII is for view purpose only & Bidder has to submit Price bid online in Excel Work Sheet on www.tenderwizard.com/BSNL].
- (ii) The price quoted by the bidder shall remain fixed during entire period of contract and shall not be subject to variation on any account. A bid submitted with an adjustable price quotation will be treated as non-responsive and rejected.
- (iii) Discount or extra charge, if any, mentioned by the bidders shall not be considered unless these are specifically indicated in the price schedule.

#### 9. EARNEST MONEY DEPOSIT (EMD)

9.1 EMD in the form of banker cheque / deposit at call receipt of a scheduled bank / **fixed deposit receipt of a Scheduled bank** / demand draft of a scheduled bank issued in favour of "Account Officer (EF) O/o CGMT BSNL HP Circle Shimla (HP), payable at Shimla (HP).

#### 9.2 The bid security may be forfeited:

- (a) If the bidder withdraws his bid during the period of bid validity specified by the bidder in the Bid form, OR
- (b) In the case of successful bidder fails
  - i. Fails to sign the contract in accordance with clause 15 Of "INSTRUCTION TO BIDDERS' UNDER Section I OR
  - ii. Fails to furnish performance security in accordance with clause 2 Of "General Conditions of Contract" Section II OR -NA-
  - iii. Fails or refuses to honor his own quoted price for any number of vehicles or part thereof
- (c) In both the above cases i.e. 9.2 (a) & (b), the bidder will not be eligible to participate in the tender for one year from the date of issue of Letter of intent. The bidder will not approach the court against the decision of BSNL in this regard.

#### 10. FORMAT AND SIGNING OF BID

10.1 The bidder shall prepare a complete set of original bid and same shall be typed or printed and all pages numbered consecutively and shall be Signed by the bidder or a person duly authorized on each page to bind the bidder the contract. The letter of authorization shall be indicated by written Power of Attorney accompanying the Bid.

- 10.2 The over writing erasures in the bid made by the bidder shall be signed by the person signing the bid.
- 10.3 A clause by clause compliance of services to be provided shall be given for all the clauses stipulated in Section I, II and III of the tender document. In case of deviation a statement of deviation shall be given separately.

#### 11. SUBMISSION OF BIDS

- a) The scanned copy of above documents (demand Draft / Pay order or Banker's cheque / FDR / deposit at call receipt or bank guarantee) is to be uploaded to the e-Tendering web site within the period of online bid submission and original should be submitted along with self attested copies of eligibility documents in the wax / adhesive tape sealed envelope, to the office of Executive Engineer(C), BSNL Civil Division, Sunder Nagar (HP) within the period mentioned in this NIT. after last date & time of submission of bid and up to by 15:00 Hrs on 27.03.2020. The envelope shall be superscripted with name of work, name of tenderer, date and time of opening of bids.
- **b)** Any bid received after the dead line for submission of bids shall be rejected and returned to the bidder unopened.

#### 12. **BID OPENING**

BSNL shall open bids in the presence of bidders or their authorized representative who wish to be present at the time of opening of bids on due date. Authorization letter to this effect shall be submitted by the bidder before they are allowed to participate in bid opening (FORMAT is given as per **SECTION-X.** 

#### 13. **EVALUATION**

- BSNL shall evaluate the bids to determine whether they are complete, whether any computational errors have been made whether documents have been properly signed and whether bids are generally in order on the basis of technical bid.
- 13.2 If there is a discrepancy between words and figures the amount in words shall prevail. Prior to detailed evaluation, BSNL will determine the substantial responsiveness of each bid to the bid document. A substantially responsive bid is one, which confirms to all the terms and conditions of bid documents without material deviation. A bid determined as substantially non-responsive will be rejected by BSNL.
- 13.3 BSNL shall evaluate in detail and compare the substantially responsive bids and comparison of bids shall be on the price of the services offered

inclusive of all levies and charges as indicated in the financial bid of substantially responsive bidders.

13.4 The bids shall be evaluated on the basis of the cost of hiring for 1500 Km basis per vehicle.

#### 14. AWARD OF CONTRACT

BSNL shall consider placement of letter of intent to those bidders whose offers have been found technically and financially acceptable. The bidder shall within 7 days of issue of Letter of Intent, give his acceptance. The hirer reserves the right to counter offer price(s) against price(s) quoted by any bidder.

#### 15. RIGHT TO VARY QUANTITY

BSNL reserves the right at the time of award of contract to increase or decrease up to 100% of the tendered quantity of vehicle running services specified in the scheduled of requirements without any change in hiring charges of the offered quantity or other terms and conditions.

#### 16. SIGNING OF CONTRACT

- 16.1 Signing of Agreement shall constitute the award of hiring contract on the bidder.
- 16.2 Upon the successful bidder furnishing the Bank performance Security Bond, BSNL shall discharge its bid EMD. -NA-

#### 17. ANNULMENT OF AWARD

Failure of the successful bidder to comply with the requirement of clause 15 shall constitute sufficient ground for the annulment of the award and forfeiture of the EMD in which event BSNL may make the award to any other bidder at the discretion of BSNL or call for new bids

#### 18. PERIOD OF VALIDITY OF BIDS

- (i) The bid shall remain valid for 60 days after the date of opening of bids. A bid valid for a shorter period shall be rejected by BSNL as non-responsive.
- (ii) A bidder accepting the request of BSNL for an extension to the period of bid validity, in exceptional circumstances, will not be permitted to modify his bid.

## **SECTION-III**

#### **GENERAL (COMMERCIAL) CONDITIONS OF CONTRACT**

#### 1. **APPLICATION**

Submission of bid against this offer shall bind the bidder for the acceptance of all the conditions specified herein or in NIT unless otherwise agreed by BSNL

#### 2. **PERFORMANCE SECURITY**

- 2.1 Performance Security shall be submitted in the form of Bank Guarantee issued by a scheduled Bank in the Performa provided at Section IX of the bid document.

- 2.2 Performance Security will be discharged after completion of contractors' performance obligations under the contract. -NA-
- 2.3 If the contractor fails or neglects any of his obligations under the contract it shall be lawful for BSNL to forfeit either whole or any part of performance security furnished by the bidder as penalty for such failure -NA-

#### 3. EXECUTION TIME LIMIT

The time period as stipulated in the contract or letter of intent shall be deemed to be essence of the contract.

#### 4. PAYMENT TERMS

Monthly bills shall be submitted in duplicate to the authority specified in contract along with duty slips / copy of log book duly signed by the user and duly certified by the competent authority.

#### 5. TERMINATION OF CONTRACT

- 5.1 BSNL may without prejudice to any other remedy for breach of contract may terminate the contract in whole or in parts.
  - (a) If the contractor fails to arrange the supply of any or all of the vehicles within the period (s) specified in the contract or any extension there of granted by BSNL.
  - (b) If the contractor fails to perform any other obligation(s) under the Contract.

5.2 BSNL may without prejudice, to other rights under law or the contract provided get the hiring of vehicles done at the risk and cost of the contractor, in above circumstances.

#### 6. TERMINATION FOR INSOLVENCY

BSNL may also by giving written notice and without compensation to the contractor terminate the contract if the contractor becomes unwilling, bankrupt or otherwise insolvent without affecting its right of action or remedy as hirer.

#### 7. FORCE MAJEURE

7.1 If any time, during the continuance of this contract, the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reason of any war, or hostility, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions. Strikes, lockouts or act of God (Hereinafter referred to as events) provided notice of happenings, of any such eventuality is given by either party to the other within 21 days from the date of occurrence thereof, neither party shall by reason of such events be entitled to terminate this contract nor shall either party have any claim for damages against the other in respect of such non performance or delay in performance under the contract shall be resumed as soon as practicable after such an event may come to an end or cease to exist, and the decision of BSNL as to whether the supplies have been so resumed or not shall be final and conclusive, provided further that if the performance in whole or part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceeding 60 days either party may, at his option terminate the contract.

#### 8. **ARBITRATION**

8.1 In the event of any question, dispute or difference arising under the agreement or in connection there with (except as to matter the decision to which is specifically provided under this agreement), the same shall be referred to sole arbitration of the C.E. (C), BSNL HP Civil Zone (North), Shimla. In case his designation is changed or his office is abolished then in such case to the sole arbitration of the officer for the time being entrusted whether in addition to the functions of the C.E. (C), BSNL HP Civil Zone (North), Shimla, or by whatever designation such officers may be called (hereinafter referred to as the said officer) and if the C.E. (C), BSNL HP Civil Zone (North), Shimla or the said officer is unable or unwilling to act as such, then to the sole arbitration of some other person appointed by the C.E. (C), BSNL HP Civil Zone (North), Shimla or the said officer. The agreement to appoint an arbitrator will be in accordance with the Arbitration and Conciliation Act, 1996.

- 8.2 The arbitrator may from time to time with the consent of both the parties enlarge the time frame for making and publishing the award. Subject to aforesaid arbitration and conciliation Act, 1996 and the rules made there under, any modification thereof for the time being in force shall be deemed to apply to the arbitration proceeding under this clause.
- 8.3 The venue of the arbitration proceeding shall be the Office of C.E. (C), BSNL HP Civil Zone (South), Shimla, or such other places as the arbitrator may decide.

#### 9. **SET OFF**

Any sum of money due and payable to the contractor (including Bank performance guarantee) under this contract may be appropriated by BSNL and set off the same against any claim of BSNL for payment of a sum of money arising out of this contract or under any other contract made by contractor with BSNL.

- BSNL reserves the right to disqualify the supplier for a suitable period who habitually failed to supply the vehicle in time. Further, the contractor whose services are not satisfactory in accordance with the specifications may also be disqualified for a suitable period as decided by the BSNL
- The bidder should give a certificate that none of his / her near relative is working in the entire unit(s) under the HP BSNL Civil Zone (North / South) Shimla. In case of proprietorship firm certificate will be given by the proprietor. For partnership firm certificate will be given by all the partners and in case of limited company by all the Directors of the company excluding Government of India / Financial Institution nominees and independent non-official part time Directors appointed by Govt. of India or the Governor of the state. Due to any breach of these conditions by the Company or firm or any other person the tender will be cancelled and Bid Security will be forfeited at any stage whenever it is noticed and BSNL will not pay any damage to the company or firm or the concerned person.

### **SECTION-IV**

#### SPECIAL CONDITIONS OF CONTRACT

- 1. The special conditions of contract shall supplement the "Instructions to the Bidders" as contained in SECTION-II and General (Commercial) Conditions of the Contract as contained in SECTION-III and wherever there is a conflict, the provisions herein shall prevail over those in SECTION-II and General (Commercial) Conditions of the contract.


