### 2. Eligibility Conditions

- a) The bidder should have required vehicle(s) of model not older than year 2017. Vehicles registered as commercial vehicles in their name(s) or Firm's name or bidder should produce affidavit for leased vehicle for use as commercial vehicles.
- (b) The bidder shall have experience of minimum six months of Similar type of contract of supplying light commercial vehicles to any Central / State Govt. organization or a Public Sector Undertaking or Reputed Private Companies / Travel Agencies registered with Tourism Department

### 3. Cost of Bidder

### 1. **APPLICATION**

Submission of bid against this offer shall bind the bidder for the acceptance of all the conditions specified herein or in NIT unless otherwise agreed by BSNL

### 2. PERFORMANCE SECURITY—NOT APPLICABLE

### **3. EXECUTION TIME LIMIT**

The time period as stipulated in the contract or letter of intent shall be deemed to be essence of the contract.

#### 4. **PAYMENT TERMS**

Monthly bills shall be submitted in duplicate to the authority specified in contract along with duty slips/copy of log book duly signed by the user and duly certified by the competent authority.

#### 5. TERMINATION OF CONTRACT

- 5.1 BSNL may without prejudice to any other remedy for breach of contract may terminate the contract in whole or in parts.
  - (a) If the contractor fails to arrange the supply of any or all of the vehicles within the period (s) specified in the contract or any extension there of granted by BSNL and also during the contract period, non-supply for a period more than 3 days per month unless it is permitted by the user.
  - (b) If the contractor fails to perform any other obligation(s) under the Contract.
- 5.2 BSNL may without prejudice, to other rights under law or the contract provided get the hiring of vehicles done at the risk and cost of the contractor, in above circumstances and get his EMD forfeited by termination the contract.

#### 6. TERMINATION FOR INSOLVENCY

BSNL may also by giving written notice and without compensation to the contractor terminate the contract if the contractor becomes unwilling, bankrupt or otherwise insolvent without affecting its right of action or remedy as hirer.

### 7. FORCE MAJEURE

7.1 If any time, during the continuance of this contract, the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reason of any war, or hostility, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions. Strikes, lockouts or act of God (Hereinafter referred to as events) provided notice of happenings, of any such eventuality is given by either party to the other within 21 days from the date of occurrence thereof, neither party shall by reason of such events be entitled to terminate this contract nor shall either party have any claim for damages against the other in respect of such non performance or delay in performance under the contract shall be resumed as soon as practicable after such an event may come to an end or cease to exist ,and the decision of BSNL as to whether the supplies have been so resumed or not shall be final and conclusive, provided further that if the performance in whole or part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceeding 60 days either party may, at his option terminate the contract.

#### 8. **ARBITRATION**

- 8.1 In the event of any question, dispute or difference arising under the agreement or in connection there with (except as to matter the decision to which is specifically provided under this agreement), the same shall be referred to sole arbitration of the C.E. (C), BSNL HP Civil Zone, Shimla. In case his designation is changed or his office is abolished then in such case to the sole arbitration of the officer for the time being entrusted whether in addition to the functions of the C.E. (C), BSNL HP Civil Zone, Shimla., or by whatever designation such officers may be called (hereinafter referred to as the said officer) and if the C.E. (C), BSNL HP Zone, Shimla. or the said officer is unable or unwilling to act as such, then to the sole arbitration of some other person appointed by the C.E. (C), BSNL HP Civil Zone, Shimla or the said officer. The agreement to appoint an arbitrator will be in accordance with the Arbitration and Conciliation Act, 1996.
- 8.2 The arbitrator may from time to time with the consent of both the parties enlarge the time frame for making and publishing the award. Subject to aforesaid arbitration and conciliation Act, 1996 and the rules made there under, any modification thereof for the time being in force shall be deemed to apply to the arbitration proceeding under this clause.
- 8.3 The venue of the arbitration proceeding shall be the Office of C.E. (C), BSNL HP Civil Zone , Shimla (HP), or such other places as the arbitrator may decide.

#### 9. SET OFF

Any sum of money due and payable to the contractor (including Bank performance guarantee) under this contract may be appropriated by BSNL and set off the same against any claim of BSNL for payment of a sum of money arising out of this contract or under any other contract made by contractor with BSNL.

- 10 BSNL reserves the right to disqualify the supplier for a suitable period who habitually failed to supply the vehicle in time. Further, the contractor whose services are not satisfactory in accordance with the specifications may also be disqualified for a suitable period as decided by the BSNL
- 11 The bidder should give a certificate that none of his / her near relative is working in the entire unit(s) under the BSNL HP Civil Zone & BSNL Electrical Zone, Shimla (HP), In case of proprietorship firm certificate will be given by the proprietor. For partnership firm certificate will be given by all the partners and in case of limited company by all the Directors of the

company excluding Government of India / Financial Institution nominees and independent non-official part time Directors appointed by Govt. of India or the Governor of the state. Due to any breach of these conditions by the company or firm or any other person the tender will be cancelled and Bid Security will be forfeited at any stage whenever it is noticed and BSNL will not pay any damage to the company or firm or the concerned person.

- 12 The near relatives for this purpose are defined as :
  - (a) Members of a Hindu undivided family.
  - (b) They are husband and wife.
  - (c) The one is related to the other in the manner as father, mother, son(s), & son's wife (daughter in law), daughter(s) & daughter's husband (son in law), brother(s) and brother's wife, sister(s) and sister's husband (brother-in-law).

## **SECTION-IV**

### SPECIAL CONDITIONS OF CONTRACT

- 1. The special conditions of contract shall supplement the "Instructions to the Bidders" as contained in SECTION-II and General (Commercial) Conditions of the Contract as contained in SECTON-III and wherever there is a conflict, the provisions herein shall prevail over those in SECTION-II and General (Commercial) Conditions of the contract.
- 2. In case the date fixed for opening of bids is subsequently declared as holiday by the BSNL, the revised schedule will be notified. However, in absence of such notification, the bids will be opened on next working day, time and venue remaining unaltered.
- 3. BSNL reserves the right to disqualify such bidders who have a record of not meeting contractual obligations against earlier contract entered into with BSNL
- 4. BSNL reserves the right to blacklist a bidder for a suitable period in case he fails to honor his bid without sufficient ground.
- 5. In circumstances the hired vehicle is involved in an accident resulting in loss or damage to property or life with respect to vehicle driver, passenger or any third party as per the liability under relevant sections of Motor Vehicle Act 1988 as amended by the motor vehicles (AMENDMENT) Act, 2001 and I.P.C., the hiring authority shall have no responsibility of whatsoever and will not entertain any claim in this regard under the said provision of the Law.
- 6. The engagement and employment of drivers and payment of wages to them as per existing provisions of various labour laws, EPF, ESI and other regulations is the sole responsibility of the contractor and any breach of such laws or regulations shall be deemed to be breach of this contract.
- 7. No sub-contracting is permissible.
- 8. The contractor shall assign the job of driving of hired vehicles only to qualified experienced licensed drivers and also assume full responsibility for the safety and security of the officers / officials as well as essential store items while running the vehicle by ensuring safe driving. BSNL shall have no direct or indirect liability arising out of such negligent, rash and impetuous driving which is an offence under relevant section under IPC and any loss caused to BSNL have to be compensated by contractor.
- 9 The contractor shall when called upon to do so, place at the disposal of BSNL such number of vehicles as may be required.
- 10. In no case a vehicle which is not registered for the commercial purpose shall be supplied to BSNL and taxes etc. due on such vehicles shall be liability of the contractor.
- 11. The contractor shall send the vehicle for periodical servicing at his cost, BSNL will not pay any mileage run for such servicing nor any deduction be made for the duration involved in such servicing. The cost of lubricants, repairs, maintenance, taxes, insurance etc. will be to the contractor's liability.
- 12. BSNL reserves right to offer counter offer price(s) against price(s) quoted by the bidder.
- 13. BSNL reserve right to offer the approved rates of L1 to L2, L3 etc. contractors for hiring the vehicles.
- 14. Whenever vehicle is required for outstation journey. The contractor will be bound to provide the vehicle for outstation journey. Night charges for the outstation journey, if any, shall be paid by BSNL.

  - iii) In case of non-availability of vehicles during extra hrs, penalty of Rs 200/per occasion shall be imposed.
