Conditions and tender forms can be had from BSNL Electrical Division, Shimla, on payment ofRs.500/- + VAT as applicable. (Non- refundable) (i.e., Rs. 569/-). All the documents shall be self attested / certified by any BSNL/MTNL Executive /Notary /Gazetted Officer of Central Govt.)
