1. ELIGIBILITY CRITERIA

The Contractors satisfying the following conditions: -

Average annual turnover during the last 3 years, ending 31stMarch of the previous financial year, should be at **Rs. 22,044/-.**

AND

The manufacturers of ETC type collectors for Solar Water Heating Systems empanelled with MNRE/Himurja /any State Department of Renewal Energy Sources

OR

Authorized supplier/ vendor approved by the above original manufacturers. The authorization letter on printed letter head of manufacture in this regard will have to be produced by the supplier/ vendor

OR

BSNL enlisted contractors in Electrical category IV(E) will have to Supply and I.T.C the System approved by MNRE/any State Department of R.E.S "

OR

Experience of having successfully completed similar works in Central Government /State Government/Central Autonomous Body/Central Public Sector Undertaking during last 7 years ending last day of the month previous to the one in which applications are invited should be either of the following :-

Three similar successfully completed works costing not less than the amount equal to **Rs.29,392/-** with solar street light-stand alone.

OR

Two similar successfully completed works costing not less than the amount equal to **Rs. 44,088/-** with solar street light-stand alone.

OR

One similar successfully completed work costing not less than the amount equal to **Rs. 58,784/-** with solar street light-stand alone.

Similar Works Means "SITC of Solar street Light-stand alone"

2. The intending Tenderer must read the terms and conditions of tender document, BSNL EW-6 & EW-8 carefully. He should only submit his tender if he considers himself eligible and he is in possession of all the documents required.

3. The contractor shall also submit and confirm:.

- Documentary proof of satisfying the eligibility conditions as per 1 above.
- CA certificate towards turn over / deposition of income tax & copy of PAN Card.
- Himachal Pradesh GST registration certificate.

The contractors who are not registered under Himachal Pradesh GST, may bid for the contract however such contractors will have to get themselves registered within 15 days from the date of issue of intimation from BSNL regarding intent to accept the tender, else their EMD shall be forfeited absolutely and the firm shall not be allowed to participate in the next tender for the same work. If the firm fails to produce Himachal Pradesh GST registration certificate on more than one occasion, the firm shall be barred from participating in all future tenders. The firm shall give an affidavit as per draft on page no.14 in this regard.

EPF and ESI registration certificate.

The contractors who are not having EPF & ESI registration, may bid for the contract however such contractors will have to get themselves registered within 15 days from the date of issue of intimation from BSNL regarding intent to accept the tender, else their EMD shall be forfeited absolutely and the firm shall not be allowed to participate in the next tender for the same work. If the firm fails to produce EPF & ESI registration certificate on more than one occasion, the firm shall be barred from participating in all future tenders. The firm shall give an affidavit as per draft on page no.14 in this regard.

- Declaration of EW-6 / EW-8, Relative Certificate & Undertaking -I & II by contractors. (As per draft on page no.15 & 16).
- Tender Cost & EMD in prescribed form.
- Original authorization of person quoting tender from Directors/ Proprietor of company.
- All the documents shall be self attested / certified by any BSNL/MTNL Executive /Notary /Gazetted Officer of Central Govt.)
- 4. Validity of tender shall be for 90 days from the date of opening of tender.
- 5. The tenders of contractors who do not deposit earnest money in the prescribed manner (in separate cover) are liable to be rejected and will not be opened.

The firm who quotes on the tender downloaded from web-site shall strictly follow the following Procedure:-

The tender shall be submitted in two envelope system.

i. First envelope shall contain tender application (If tender downloaded from Web), tender fee, attested documents (self attested and counter attested by any executive of BSNL/MTNL or Gazetted officer of GOI; otherwise all originals of eligibility criteria shall be produced for verification at the time of tender opening) proving fulfillment of eligibility criteria as per the tender notice & EMD in proper form. Separate D.D. should be attached for tender fee & EMD. ii. Second envelope shall contain duly filled tender document.

ii. Second envelope shall contain duly filled tender document. The same shall be clearly written on the envelopes. The 1st envelope containing Tender fee, attested documents proving fulfillment of eligibility Criteria & EMD in proper form shall be opened first.

In case: -

(i) Tender fee is not submitted in proper form.

(ii) (iii) Firm

fails to fulfill eligibility criteria on the basis of document submitted in first envelop.

(iv) The performance of tenderer is not found satisfactory.

The second envelope shall not be opened.

EMD is not in proper form.

If the day of opening of the tender declared as a Holiday then the tender will be opened on the next working day. The tenders shall neither be issued nor received through POST / COURIER. Conditional Tenders or Tenders with conditional rebates shall be summarily rejected. If any difference/ discrepancies found between down loaded Tender form, any hard copy issued from Division Office, the contents in Draft NIT issued from this or higher offices will be final & binding.
