✤ The Contractor shall have to possess a valid ELECTRICAL LICENCE of appropriate Voltage Issued by any State Govt. Under Clause 45 of compilation of Indian Electricity Rules 1956 or as amended from time to time, provided notification in official Gazette, exempt, on such condition.

The contractor shall also submit and confirm:

i.Documentary proof of satisfying the eligibility conditions as per 1 above

- ii. CA certificate towards turn over /deposition of income tax & PAN Card
- iii. Himachal Pradesh GST registration certificate.

The contractor who are not registered under Himachal Pradesh GST may bid for the contract however such contractors will have to get himself registered within 15 days from the date of issue of intimation from BSNL regarding intent to accept the tender, else their EMD shall be forfeited absolutely and the firm shall not be allowed to participate in the next tender for the same work.
