The Contractors satisfying the following conditions:

Average annual turnover during the last 3 years, ending 31st March of the previous financial year, should be at least Rs. 32476/-

And

BSNL enlisted contractor in Electrical category IV (E) and above.

OR

- Original Manufacturer of Inverter type Split AC units confirming to NIT Specifications. (OR)
- The dealer authorized by the Original Manufacturer of Inverter type Split AC units confirming to NIT Specifications. The copy of letter of Authorization from the manufacturer will have to be produced by the dealers.

Note :- Bidder has to submit self attested copies of completion certificate. The certificate should have been issued by officer not below the rank of Executive Engineer/ AGM for Govt./PSU/CPSU.

 GeM registered vendors handling with Inverter type Split AC units confirming to NIT Specifications are also eligible to participate in above tender. Self attested copy of Gem Registration Certificate will have to be produced by the bidders.

The contractor shall also submit and confirm:

The firm shall give an affidavit as per draft on page no.**6** in this regard. Contractors whose turnover is less than prescribed limit as per GST act Shall submit declaration that they are not covered under GST ACT

• EPF and ESI registration certificate.

The contractors who are not having EPF & ESI registration, may bid for the contract however such contractors will have to get themselves registered within 15 days from the date of issue of intimation from BSNL regarding intent to accept the tender, else their EMD shall be forfeited absolutely and the firm shall not be allowed to participate in the next tender for the same work. If the firm fails to produce EPF & ESI registration certificate on more than one occasion, the firm shall be barred from participating in all future tenders. The firm shall give an affidavit as per draft on page no.**7** in this regard.

• Declaration of EW-6 / EW-8, Relative Certificate & Undertaking -I & II by contractors (As per draft on page no.5)

• Tender Cost & EMD in prescribed form.
