Turnover: (I) Average annual turnover during the last 3 years, ending 31st March of previous financial year, should be at least 30% of the estimated cost put to tender.

Physical norms: Firms satisfying the following conditions:

(II) The lift manufacturer of the makes proposed in the NIT. (Refer p.no. 43 & 44, List of approved makes along with special note at the end of LIST.)

(IV) Experience of having successfully completed similar works in Central Government/State Government /Central Autonomous Body/Central Public sector Undertaking during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following:-

Three similar successfully completed works costing not less than the amount equal to 40% of the estimated cost put to tender.

OR

Two similar successfully completed works costing not less than the amount equal to 60% of the estimated cost put to tender.

OR

One similar successfully completed work costing not less than the amount equal to 80% of the estimated cost put to tender.

- Note 1:-The contractor shall produce authorization certificate in original from the manufacturer for participation in tender and supply of spare parts, technical support etc. during the currency of the AMC contract.
 - 2) Only BSNL Corporate Office (EW) approved makes of lift shall be provided. Apart from the approved makes any other make approved by BSNL CO (EW) till the last date of opening of tender shall also be accepted.
 - 3) The work Completion Certificate issuing Authority in respect of IV above shall not be below the rank of Executive Engineer (E).
 - 4) The work shall be awarded only to those agencies whose is having valid product approval in BSNL on the last date of submission of tender.

- c) Valid GST Registration No or exemption certificate No.
- 4.1 The bidders shall submit necessary documentary proof showing that they meet the eligibility criteria along with their tender bid. All documents submitted will also be self attested by the bidder.
- 5. Bid Security/EMD:
- 5.1 The bidder shall furnish the bid EMD in one of the following ways:-
