Eligibility Conditions

The Contractors satisfying the following conditions:

Average annual turnover during the last 3 years, ending 31starch of the previous financial year, should be at least 30% of the estimated cost put to tender.

And

BSNL enlisted contractor in Electrical category IV (E) and above.

o OR

One similar successfully completed work costing not less than the amount equal to 80% of the estimated cost put to tender.

The contractor shall also submit and confirm:

- Documentary proof of satisfying the eligibility conditions as per 1 above
- CA certificate towards turn over /deposition of income tax & PAN Card
- Valid GST Registration as per GST Law (SGST/CGST/IGST as applicable) certificate.

The contractors who are not having Valid GST Registration as per GST Law (SGST/CGST/IGST as applicable), may bid for the contract however such contractors will have to get themselves registered within 15 days from the date of issue of intimation from BSNL regarding intent to accept the tender, else their EMD shall be forfeited absolutely and the firm shall not be allowed to participate in the next tender for the same work. If the firm fails to produce Valid GST Registration as per GST Law (SGST/CGST/IGST as applicable) certificate on more than one occasion, the firm shall be barred from participating in all future tenders. The firm shall give an affidavit as per draft on page no.6 in this regard.

• EPF and ESI registration certificate.

The contractors who are not having EPF & ESI registration, may bid for the contract however such contractors will have to get themselves registered within 15 days from the date of issue of intimation from BSNL regarding intent to accept the tender, else their EMD shall be forfeited absolutely and the firm shall not be allowed to participate in the next tender for the same work. If the firm fails to produce EPF

& ESI registration certificate on more than one occasion, the firm shall be barred from participating in all future tenders. The firm shall give an affidavit as per draft on page no.7 in this regard.

- Declaration of EW-6 / EW-8, Relative Certificate & Undertaking -I & II by contractors (As per draft on page no.5)
- Tender Cost & EMD in prescribed form.

All the documents shall be self attested / certified by any BSNL/MTNL Executive /Notary /Gazetted Officer of Central Govt.)
