Three similar successfully completed works costing not less than the amount equal to 40% of Estimated Cost. Two similar successfully completed works costing not less than the amount equal to 60% of Estimated Cost.

OR

- One similar successfully completed work costing not less than the amount equal to 80% of Estimated Cost.
