- 4. Eligibility Criteria: The bidder should have the following eligibility conditions:
 - (a) Financial norms:

Turnover: (I) Average annual turnover during the last 3 years, ending 31st March of previous financial year, should be at least 30% of the estimated cost put to tender.

AND

BSNL Enlisted Contractors in Electrical Category of respective class as per their tendering limits.

OR

BSNL CO (Electrical) approved Engine manufacturer with the approved capacity of engine not less than the DG set capacity proposed in the NIT i.e. **250 KVA**.

OR

OEM authorized by BSNL CO (Electrical) approved Engine manufacturer with the approved capacity of engine not less than the DG set capacity proposed in the NIT i.e. **250 KVA**. The letter of Authorization in Original from the Engine manufacturer will have to be produced by the OEMs.

OR

Experience of having successfully completed similar works in Central Government/State Government /Central Autonomous Body/Central Public sector Undertaking during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following: -

Three similar successfully completed works costing not less than the amount equal to 40% of the estimated cost put to tender with DG set capacity not less than **200 KVA**.

OR

Two similar successfully completed works costing not less than the amount equal to 60% of the estimated cost put to tender with DG set capacity not less than **200 KVA**.

OR

One similar successfully completed work costing not less than the amount equal to 80% of the estimated cost put to tender with DG set capacity not less than **200 KVA**.

(Similar work means work of Supplying, Installation, Testing & Commissioning of "Ready To Use" Diesel Engine Alternator set (air / liquid cooled) along with sound proof enclosure and Manual control panel / AMF panel.).

The work Completion Certificate issuing Authority in respect of II above shall not be below the rank of Executive Engineer (E).

b) Valid PAN No.

c) Valid GST Registration No or exemption certificate No.

- 4.1 The bidders shall submit necessary documentary proof showing that they meet the eligibility criteria along with their tender bid. All documents submitted will also be self-attested by the bidder.
- 5. Bid Security:

5.1 The agency has to furnish Bid security declaration as per Performa at page No.20

5.2 The MSE units shall be exempted from submission of Tender Cost on production of requisite proof in respect of valid certification from MSME for the tendered item.

- 6. Date & Time of Submission of Tender bids: As per table in Section I, point no. 1. Note 4: In case the date of submission (opening) of bid is declared to be a holiday, the date of submission (opening) of bid will get shifted automatically to next working day at the same scheduled time. Any change in bid opening date due to any other unavoidable reason will be intimated to all the bidders separately.

- 8. Place of opening of Tender bids: BSNL, Electrical Division Sundernagar, Himachal Pradesh.
- 8.1 In case of tenders invited through e-tendering process, the tenders shall be opened through 'Public Online Tender Opening Event (POTOE)'. BSNL's Tender Opening Officers as well as authorized representatives of bidders can attend the Public Online Tender Opening Event (TOE) from the comfort of their offices. Kindly refer clause 8 of Section-4 Part C of Tender document for further instructions.
- 8.2 In addition, authorized representatives of bidders (i.e. vendor organization) can attend the TOE at the office of "The Executive Engineer (E), BSNL, Electrical Division Sundernagar, Himachal Pradesh", where BSNL's Tender Opening Officers would be conducting Public Online Tender Opening Event (TOE).
- 9. Tender /bids received after due time & date will not be accepted.
- 10. Incomplete, ambiguous, Conditional, unsealed (in case of manual tender) tender bids are liable to be rejected.
- 11. "The Superintending Engineer (E), BSNL, Electrical HP Zone, Shimla" reserves the right to accept or reject any or all tender bids without assigning any reason. He is not bound to accept the lowest tender.
- 12. The bidder shall furnish a declaration in his tender bid that no addition / deletion / corrections have been made in the downloaded tender document being submitted and it is identical to the tender document appearing on the website.
- 12.1 In case of any correction/ addition/ alteration/ omission in the tender document, the tender bid shall be treated as nonresponsive and shall be rejected summarily.
