Three similar successfully completed works costing not less than the amount equal to Rs.7520/-•

Two similar successfully completed works costing not less than the amount equal to Rs. 11280/-•

One similar successfully completed work costing not less than the amount equal to Rs. 15040/-•

OR

BSNL enlisted contractors in Electrical category of IV (E) or above•

Similar works means repairing and servicing works of AC units.

Note: - For works executed in Central Government /State Government /Central Autonomous Body/ Central Public sector Undertaking. The Completion Certificate should be issued by Executive Engineer or Equivalent Officer.

The contractor shall also submit and confirm:

- i.Documentary proof of satisfying the eligibility conditions as per 1 above
- ii. CA certificate towards turn over /deposition of income tax & PAN Card
- iii. Himachal Pradesh GST registration certificate.

The contractor who are not registered under Himachal Pradesh GST may bid for the contract however such contractors will have to get himself registered within 15 days from the date of issue of intimation from BSNL regarding intent to accept the tender, else their EMD shall be forfeited absolutely and the firm shall not be allowed to participate in the next tender for the same work. The firm shall give an affidavit as per draft on P. No. 5 in this regard.

Separate D.D. should be attached for tender fee & EMD.

ii. Second envelope shall contain duly filled tender document.

The same shall be clearly written on the envelopes.

The 1st envelope containing Tender fee, attested documents proving fulfillment of eligibility Criteria & EMD in proper form shall be opened first..

In case: -

- (i) Tender fee is not submitted in proper form. (ii) EMD is not in proper form.
- (iii) Firm fails to fulfill eligibility criteria on the basis of document submitted in first envelop.
- (iv) The performance of tenderer is not found satisfactory.

The second envelope shall not be opened.
