If the Envelope-I in not annexed or the documents submitted in the Envelope-I are found incomplete or not in proper form against requirements as given below herein, then Envelope-2 containing price bid will not be opened at all and shall be returned to the tenderer on spot, if the tenderer is present at the time of tender opening.

- 12. No employee in BSNL/ Govt. of India is allowed to work as a contractor for a period of two years of his retirement from service without the prior permission. The contract is liable to be cancelled if either the contractor or any of his employees is found at any time to be such a person who had not obtained the permission as aforesaid before submission of tender and engagement in the contractor's service.
- 13. The tender for the works shall not be witnessed by the contractor who himself/themselves has/ have tendered or who may and has/have tender for the same

 - c) The one is related to the other in the manners as father, mother, son(s) & son's wife (daughter in law), Daughter(s) & daughter's husband (son in law), brother(s) & brother's wife, sister(s) & sister's husband (brother in law).

The company or firm or any other person is not permitted to tender for works in BSNL Unit in which his near relative(s) is/are posted. The Unit is defined as SSA/Circle/Chief

Engineer/Chief Archt/Corporate Office for non-executive employees and all SSA in a Circle including Circle Office/Chief Eng./Chief Archt/Corporate office for executive employees (including those called as Gazetted Officers at present). The tenderer should give a certificate that none of his/her such near relative is working in the units as defined above where he is going to apply for tender/work. In case of proprietorship firm certificate will be given by the proprietor, for partnership firm certificate will be given by all the partners and in case of limited company by all the Directors of company. Any breach of these conditions by the company or firm or any other person, the tender/work will be cancelled and earnest money/Security deposit will be forfeited at any stage whenever it is so noticed.
