1. **ELIGIBILITY CRITERIA**

The Contractors satisfying the following conditions: -

- Average annual turnover during the last 3 years, ending 31st March of the previous financial year, should be at least 30% of the estimated cost put to tender
- **SNL** enlisted contractors in Electrical category of Class-II or above.

- ❖ Experience of having successfully completed similar works (Comprehensive Maintenance and Operation of Electro mechanical services) in BSNL comprising of either substation or air conditioning service as part of scope of work during last 7 years ending last day of month previous to the one in which applications are invited, should be either of the following:-
- Three similar successfully completed works costing not less than the amount equal to 40% of the estimated cost put to tender

OR

Two similar successfully completed works costing not less than the amount equal to 60% of the estimated cost put to tender

One similar successfully completed work costing not less than the amount equal to 80% of the estimated cost put to tender.

Note 5: The estimated cost of one year shall be considered to evaluate the eligibility criteria.

Note 6: "Similar Work" means operation and comprehensive maintenance of Electromechanical Service comprising of El along and either Substation or Air conditioning or DG set service as part of scope of work

The firm /contractor should possess an applicable voltage category valid Electrical License of Himchal Pradesh and the agency has to submit the documentary proof for this. The decision of tender opening authority is final.

- 2. The intending Tenderer must read the terms and conditions of tender document, BSNL EW-6 & EW-8 carefully which can be accessed from web site www.etenders.gov.in or www.hp.bsnl.co.in. He should only submit his tender if he considers himself eligible and he is in possession of all the documents required.
- 3. The intending bidders must have valid Class-III digital signature to submit e-Tender.
- **4.** The e-Tender will be submitted online in two Electronic Envelope system.
 - Electronic Envelope No-I: Eligibility documents & Technical Bid (e-Tender).
 - Electronic Envelope No-II: Price Bid.
- 5. Tender Cost, EMD & other documents are required to be submitted offline in the prescribed form in the o/o Executive Engineer (Elect.), BSNL Electrical Division II, First Floor, Block no. 35, SDA Complex, Kasumpati, Shimla-171009 up to the Last date and time of submission of EMD, Tender Cost & Other documents. - **6.** On Line e-Tender can only be submitted after uploading following valid scanned documents (i.e. e-Envelope-I) related to eligibility conditions as per point no-1 above up to Last date and time of online submission/uploading of E-tender.
- Documentary proof of satisfying the eligibility conditions as per 1 above.
- * CA certificate towards turn over / deposition of income tax & copy of PAN Card.
- EPF and ESI registration certificate.
 - The contractors who are not having EPF & ESI registration, may bid for the contract however such contractors will have to get themselves registered within 15 days from the date of issue of intimation from BSNL regarding intent to accept the tender, else their EMD shall be forfeited absolutely and the firm shall not be allowed to participate in the next tender for the same work. If the firm fails to produce EPF & ESI registration certificate on more than one occasion, the firm shall be barred from participating in all future tenders. The firm shall give an affidavit as per draft on page no.15 in this regard.
- Declaration of EW-6 / EW-8, Relative Certificate & Undertaking -I & II by contractors. (As per draft on page no.18).
- Tender Cost & EMD in prescribed form.
- Original authorization of person quoting tender from Directors/ Proprietor of company.
- The Integrity Pact (As per draft on page no.19 to 22.agreement shall be executed in Rs 100/- non judicial stamp paper)
- 7. Validity of tender shall be for 90 days from the date of opening of tender.
- **8.** The bidding process will be accepted only through e-Tendering platform. As tenders are invited through e-Tendering process, physical copy of the tender document would not be available for sale. Contractor can upload documents in the form of JPG format, PDF format and any other format as permissible by the e- tendering portal.
