- i) <u>Performance Guarantee:</u> The contractor is required to furnish performance guarantee for an amount equal to 5% of the contract value in the form of CDR/FDR/DD or Bank guarantee (of a nationalized / Scheduled Bank in a standard format **Annexure-II**) within two weeks from the date of issue of award letter. This period can be further extended by the Engineer-in-charge up to a maximum period of 2 weeks on written request of Contractor. The validity period of the performance security in the form of bank guarantee shall be two years and three months from the date of award of work.
- ii)<u>Security deposit</u>: In addition to performance guarantee stated above, a sum @ 10% of the gross amount of the bill shall be deducted from each running bill of the contractor till the sum be deducted with the sum already deposited as performance guarantee, will amount to security deposit of 10% of the Tendered value of the work.
- 08 The acceptance of a tender will rest with the Executive Engineer (E) BSNL Electrical Division, Shimla who does not bind himself to accept the lowest tender or any other tender and reserves to himself the Authority to reject lowest or all the tenders received without assigning any reason. All tenders in whom any of the prescribed conditions are not fulfilled or incomplete in any respect are liable to be rejected. **Tenders with any condition including that of conditional rebates shall be rejected forthwith summarily.**
- 09 Canvassing in connection with tender is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable for rejection.
- 11. The BSNL reserves itself the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rates quoted.
- 12. No employee in BSNL/ Govt. of India is allowed to work as a contractor for a period of two years of his retirement from service without the prior permission. The contract is liable to be cancelled if either the contractor or any of his employees is found at any time to be such a person who had not obtained the permission as aforesaid before submission of tender and engagement in the contractor's service.
- 13. The tender for the works shall not be witnessed by the contractor who himself/themselves has/ have tendered or who may and has/have tender for the same work. Failure to observe this condition would render tenders of the contractors tendering as witnessing the tender is/are liable for summarily rejection.
- 14. The tenders for the work shall remain open for acceptance for a period of 90 days from the date of opening of the tenders.

- 21. The near relatives of any BSNL Employee either directly recruited or on deputation are prohibited from participation in tenders and execution of works in the different units of BSNL
 - i. The near relatives for this purpose are defined as.
 - a) Members of a Hindu undivided family.
 - b) They are husband and wife.
 - c) The one is related to the other in the manners as father, mother, son(s) & son's wife (daughter in law), Daughter(s) & daughter's husband (son in law), brother(s) & brother's wife, sister(s) & sister's husband (brother in law).

The company or firm or any other person is not permitted to tender for works in BSNL Unit in which his near relative(s) is/are posted. The Unit is defined as SSA/Circle/Chief Engineer/Chief Archt/Corporate Office for non-executive employees and all SSA in a Circle including Circle Office/Chief Eng./Chief Archt/Corporate office for executive employees (including those called as Gazetted Officers at present). The tenderer should give a certificate that none of his/her such near relative is working in the units as defined above where he is going to apply for tender/work. In case of proprietorship firm certificate will be given by the proprietor, for partnership firm certificate will be given by all the partners and in case of limited company by all the Directors of company. Any breach of these conditions by the company or firm or any other person, the tender/work will be cancelled and earnest money/Security deposit will be forfeited at any stage whenever it is so noticed. 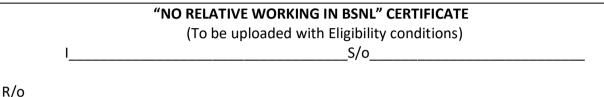

- 21. The work is to carry out according to the drawings issued, kept in the office of

Engineer-in-charge who reserves the right to change the layout as and when required according to changed site conditions at any stage .The wiring and conduit routes are to be marked at site first and got approved by the Engineerin-charge for commencement of actual work. No extra payment shall be made on this account.

- 22. The electrical works shall be carried out in close with the civil work in such a way that at no stage the electrical works lacs behind the civil works.
- 23. No compensation shall be payable to the contractor for any damage caused by rain, fire, wind, storm. flood, or otherwise and no claim on this account shall be entertained.
- 24. The contractor shall maintain in good condition all work executed till the completion of work allotted to him.
- 25. No sharp edges of conduit shall be left unrounded.
- 26. The 5A/15A sockets should be multiple pin type
- 27. All the material to be used on the work shall be (S) marked and if ISI marked is not manufactured the confirmation to ISS shall be used. The same shall be approved by Engineer-in-Charge before use .All rejected material is to be removed from the site of work immediately at contractor's on cost.
