1. Eligibility Conditions

The Contractors satisfying the following conditions: -

• BSNL enlisted contractor in Electrical category III (E) and above.

OR

• The Contractors satisfying the following conditions: -The contractor enlisted in CPWD, M.E.S. and Railways in respective class as per their tendering limits.

AND

Average annual turnover during the last 3 years, ending 31st March of the previous financial year, should be at least **Rs. 2,29,186/-**

AND

Experience of having successfully completed similar works in Central Government/State Government /Central Autonomous Body/Central Public Sector Undertaking during last 7 years ending last day of month previous to the one in which NIT applications are invited, should be either of the following :-

> Three similar successfully completed works costing not less than the amount equal to Rs. 3,05,581/-

OR

Two similar successfully completed works costing not less than the amount equal to **Rs. 4,58,372**/-OR

> One similar successfully completed work costing not less than the amount equal to Rs. 6,11,162/-

The Contractor shall have to possess a valid ELECTRICAL LICENCE of appropriate Voltage Issued by any State Govt. Under Clause 45 of compilation of Indian Electricity Rules 1956 or as amended from time to time, provided notification in official Gazette, exempt, on such condition.

The contractor shall also submit and confirm:

- Documentary proof of satisfying the eligibility conditions as per "1" above, copy of PAN card, copy of CA certificate for turnover, Original authorization of person quoting the tender from Directors/ Proprietor of the company, Near relative certificate from or on behalf of Directors/ Proprietor of the company. (All the documents shall be self attested / certified by any BSNL Executive /Notary
- /Gazetted Officer of Central Govt).

- ➤ If the firms do not have ESI & EPF registration, they will though be allowed to participate in the bid process, but they will have to get the ESI & EPF registration within15 days from the date of issue of intimation from BSNL regarding intent to accept the tender, else their EMD shall be forfeited absolutely and the firm shall not be allowed to participate in the next tender for the same work. If the firm fails to produce ESI & EPF registration certificate on more than one occasion, the firm shall be barred from participating in all future tenders.
