# 5.0 SUBMISSION OF TENDERS:

### 5.4 The envelope-II shall contain the following: -

- 5.4.1 Tender document containing terms & conditions, Specifications, schedule of quantities etc. complete as the original tender documents got issued from BSNL or downloaded from the internet.
- 5.4.2 The rates and amounts should be filled only in the schedule of quantities attached thereto.

### 6.0 <u>Tender opening: -</u>

Tenders, which should always be placed in sealed envelope, in the manner detailed at **Para no. 5.0 above**, will be received and opened on the due dates in **BSNL**, **Electrical Sub Division**, **181 ANAND VIHAR SAPROON SOLAN H.P. 173212 up to 15:00 Hrs & 15:30 Hrs. respectively** by Executive Engineer (E) or his authorized representative in his office.

- 6.1 **Envelope-I** containing earnest money, tender cost and documents pertaining to eligibility etc. (As per **clause 5.3** above) shall be opened first on the due date.
- 6.2 In case **Envelope-I** is not annexed or tender cost, EMD, Eligibility documents etc. not found in proper form, the **Envelope-II** containing tender documents will not be opened at all and such unopened tender shall be returned on spot to the bidder or his representative during the process of opening of tenders. The cost of tender documents deposited for tender issue/Demand Draft along with downloaded tender shall not be refunded, even if bidder is found ineligible.
- 6.3 After the opening of **Envelope-II of eligible bidders**, the Tender documents containing terms & conditions, specifications and Schedule of quantities etc. shall be evaluated by BSNL.
- 6.4 If a holiday is declared on the tender opening day, the tenders will be opened on the next working day.
- **7.0** The tender should be properly bound and sealed. In case of loose/spiral bound submission of tender, the tender shall be liable for rejection. (In case of the downloaded tender documents from the internet).
- 8.0 Every page of downloaded tender shall be signed by the tenderer with stamp (seal) of his firm/organization and the tenderer shall furnish a declaration" that No addition/ deletion/ correction have been made in the tender document, submitted and it is identical to the tender document appearing on website. (In case of the downloaded tender documents from the internet)".
- **9.0** If it is found at any stage of tender scrutiny after submission of tender that the bidder has made any correction/addition/alternation/omission in tender documents vis-à-vis tender documents available on the website/original draft NIT in office, the bid shall be treated as non responsive and shall be summarily rejected and the EMD deposited by tenderer shall be forfeited in addition to any other action as per prevalent rules.
- **10.0** The conditional tender or tenders with conditional rebate shall be summarily rejected. However tenders with unconditional rebate will be considered.
- **11.0** The tenderer shall submit the original computer printout of the tender documents downloaded from the internet. The photocopy shall not be accepted.
- **12.0** The tender documents shall not be issued / sent through Post / Courier.
- **13.0** Canvassing whether directly or indirectly, in connection with tenders is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable to rejection.

### 14.0 WORK/QUANTITY DISTRIBUTION:

14.1 100% quantity shall be awarded to lowest bidder.

### 15.0 <u>Performance guarantee:</u>

The successful tenderer shall upon issue of letter of tender acceptance, shall be required to furnish irrevocable performance guarantee for an amount equal to 5% of the contract value in the form of CDR/FDR/DD/ Bank Guarantee (Annexure-III to the tender documents) within 15 days from the date of issue of acceptance of tender by the BSNL. In the event of failure on the part of the successful tenderer to furnish the performance guarantee within 15 days, the earnest money deposited (EMD) will be forfeited and tender shall be cancelled.

- **16.0** The Notice Inviting Tender shall form part of the contract document, In accordance with clause-1 of the contract, the tender acceptance letter shall be issued first in favour of the successful tenderer/contractor. The contract shall be deemed to have come into effect on issue of communication of acceptance of the tender. On such communication of acceptance, the successful tenderer/ contractor shall within 15 days from such date, formally sign the contract that includes all relevant documents.
- 16.1 The Notice Inviting Tender, all the documents including additional conditions, specifications and drawings, if any, forming part of the tender and as issued at the time of invitation of tenders and acceptance thereof together with any correspondence leading thereto
- 16.2 Agreement shall be drawn with the successful tenderer on prescribed standard Form No. B.S.N.L.W.-8 which is available as a B.S.N.L. Publication, Tenderer shall quote his rates as per various terms and conditions of the said form which will form part of the agreement
- **17.0** Tenderers are advised to inspect and examine the site and its surrounding and satisfy themselves before submitting their tenders as to the nature of the ground and the form and nature of the site, the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their tender. A tenderer shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charges consequent on any misunderstanding or otherwise shall be allowed. The tenderer shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity, access facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of tender by a tenderer implies that he has read this notice and all other contract documents and has made him self aware of the scope and specifications of the work to be done and of conditions and local conditions and other factors having a bearing on the execution of the work.
- **18.0** The competent authority on behalf of the BSNL does not bind himself to accept the lowest or any other tender, and reserves to himself the authority to reject any or all of the tenders received without the assignment of a reason. All tenders in which any of the prescribed conditions are not fulfilled or are incomplete in any respect are liable to be rejected.
- **19.0** The competent authority on behalf of BSNL reserves to himself the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rate quoted.

**20.0** The tender of the works shall remain open for acceptance for a period of **90 days** from the date of opening of tenders. If any tenderer withdraws his tender before the said period or date of issue of letter of acceptance/intent, whichever is earlier or makes any modifications in terms and conditions of the tender which are not acceptable to BSNL, then BSNL shall without prejudice to any right or remedy be at liberty to forfeit 50% of the said earnest money as aforesaid.

No exemption certificate for payment of EMD is acceptable.

- **21.0** The company or firm or any other person is not permitted to tender for works in BSNL Unit in which his near relative(s) is (are) posted. (Details as per ANNEXURE -I attached)
- **22.0** No Engineer of gazetted rank or other gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the Government of India is allowed to work as contractor for a period of two years after his retirement from Government service, without the previous permission of the Government of India in writing. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government of India as aforesaid before submission of the tender or engagement in the contractor's service.

# SPECIAL AND ADDITIONAL CONDITIONS)- SECTION-IV

The contractor shall read carefully the following conditions and shall quote accordingly.

# 1.0 EARNEST MONEY DEPOSIT:

- 1.1 Validity period: The validity period of Earnest Money deposit should be kept 30 days beyond the Tender validity i.e. 90+30=120 days, as the tender validity period is 90 days.
- 1.2 Extension of Validity period: In case, where the letter of award of work can not be placed with in the validity period of tender, the BSNL can request all tenderers to extend the validity of their respective tenders and the earnest money deposit by a reasonable period. In such cases, extension of validity of earnest money deposit by 30 days beyond the extended validity date of tender should also be asked for. While BSNL can make the request for extension, the tenderer is free to either extend the validity or refuse the request to extend the validity.

### SECTION - VI ADDITIONAL SPECIFICATIONS FOR THE WORK (E.I. & FANS)

- 1 The work shall be done as per CPWD specifications for electrical works as amended from time to time and Indian Electricity Rules as amended up to date
- 2 The work shall be supervised by a qualified over-sear.
- 3 The Engineer-in charge or the duly authorised representative, at the site work, will give the layout of the work.
- 4 The following wiring shall be done in separate circuits.
  - A) Power plug wiring.
  - B) Light and fan point wiring.
  - C) Emergency light and fan point wiring.
  - D) Telephone wiring.
  - E) Circuit wiring.
  - F) Sub main wiring.
- 5 The number of power plug points shall be one per ckt. As in H.P. heater are used on each ckt.
- 6 The earthing sets shall be provided in the presence of the Engineer-in-charge or his authorized representative.
- 7 The contractor will have to submit the completion plan to scale in triplicate in ammonia printed i.e. Blue prints before finally paid, failing which 2.5% of the value of work subject to a ceiling of Rs. 2500/- will be recovered from his final bill.
- 8 <u>The contractor will have to give the following tests at his cost and intimate</u> test results <u>before final bills are paid. Nothing extra will be paid to him on this accounts.</u>

A) Earth Test.

- B) Polarity Test.
- C) Insulation Test.
- D) Earth continuity test of the recessed conduit pipes.
- 9 Any damage done to the building by the contractor during the execution of work shall have to made good at his cost and risk. If he does not do it himself within a reasonable time determined by the Executive Engineer (Elect) then the same will be get done at his cost departmentally after giving notice to him.
- 10 The outlet box is for switches and pipes or conduits etc. For different categories of conduits runs catering for different type of electric wiring as mentioned in clause(4) above shall be painted inside with different colors each signifying the different categories mentioning so as to avoid mixing of various circuits and their wiring and nothing extra will be paid for this account.
- 11 At the time of laying conduit pipe in the slab and in recess the contractor will keep fish wire of 14 S.W.G. (G.I.) wire through conduit/pipe and will have to take special care so that the conduits do not pass through air conditioning nuts grills, columns, beams etc. If any such necessity is foreseen special written permission of E.E. (Elect) will be obtained before such work is carried out, in case of failure the contractor will not be paid this account. Successful tenderer should recess the conduit in the walls before they are plastered and in collaboration with the cost of the contractor. The conduit/pipes should be mechanically and electrically continues.

- 12 The Bakelite covers of the tumbler switches; plug & sockets etc. shall not be removed or broken for taking connections. It shall be done at their backs by providing suitable wooden rider in the I.C. boxes, where found necessary. All I.C. boxes for switches, plugs and regulators etc. shall be provided with thick bakelite sheet covers.

Any damage done to the building /departmental property by the contractor during the execution of work shall be made good by the contractor at his risk and cost, if the damage are not made good by the contractor in reasonable time determined by the engineer-in-charge the same will be got done at his cost departmentally after serving notice to him
- 5. All the material should be as per the approved list attached with the schedule. Any material which is not covered in it, shall be ISI mark and may be got approved from Engineer-in-charge.
- 6. No extra payment will be made for any kind of transportation. The firm shall quote the rate of each item on lump sum basis including all taxes, levies, octroi and works contract tax. No octroi exemption and sales tax certificate should be given by the department.
- 7. The spare parts used should be from the genuine spare parts manufacturers.
- 8. Dismantled material will be contractors property and rate should be quoted accordingly
- 9. The work will remain under guarantee for six month after the handing over the site
- 10. INDULGING CONTRACTOR IN CRIMINAL/ ANTISOCIAL ACTIVITIES AND CASES UNDER INVESTIGATION / CHARGE SHEETED BY CBI OR ANY OTHER GOVERNMENT AGENCIES ETC. : If the CBI/ Independent External Monitor (IEM)/ Income Tax/ Central Excise/ Custom Departments recommends such a course- Action will be taken as per the directions of CBI or concerned department.
- 11. TERMINATION OF CONTRACT ON DEATH OF CONTRACTOR: Without prejudice of any of the rights or remedies under this contract, if the contractor dies, the Engineerin-charge on behalf of the BSNL shall have option of terminating the contract without compensation to the contractor.

NOTE: - The replacement of material shall be with the same rating and make as that of the original. However, in case of non-availability of a particular make listed in NIT, the Engineer-in-charge will approve the alternate make
