SECTION-II SCOPE OF WORK

The Bidder is required to provide commercial vehicles fully conforming to RTA/RTO regulation along with fuel, driver etc. All maintenance of vehicle & road taxes are to be borne by the Vendor.

The vehicles will be requisitioned on monthly requirement basis.

The additional requirement of vehicles to meet the 'Peak Operational requirement' if any will be based on the same rate quoted for regular work. The number of such requirement is not anticipated in this tender but may not exceed one vehicle in each section of the above estimated quantity. The requisitioned vehicle will be used as per the requirement of BSNL within SSA. However DE Incharge of the Division may utilize the vehicles within division as per actual requirement.

SECTION-III

SERVICE PROVIDER'S OBLIGATIONS

- 1. **Service to be provided** is supply on demand vehicles with licensed drivers, registered as commercial vehicles on hiring basis for running within the jurisdiction of GMTD BSNL Shimla. The essence of the contract is to provide Prompt, Punctual, Efficient, Safe, Courteous and Quality Service.
- 2. **Quantity of Vehicles** to be hired are shown in the Scope of Work. However BSNL shall place the order only as per the actual requirement from time to time from the empanelled transporters as per Clause 7 of Section IV of tender document.
- 3. **Duty Hours of** vehicles are normally for ten hours per day on all working days of month except Holidays. However actual duty hours / days shall be specified by actual users of vehicle.
- 4. **Notice period for supply of vehicles** shall be two day in advance for Regular requirements. A written notice will be issued to the contactor for this.
- 5. **Reporting Place for vehicles** is within the jurisdiction of GMTD BSNL Shimla. Actual place of reporting shall be specified by concerned users of vehicles.
- 6. **Counting of Distance** will be from the starting point of the user and closing at the point wherever user completes his / her travel. The distance covered in each way between user delivery address and the garage/ normal parking place will be allowed on actual basis or 5 KMs whichever is less.
- 7. Accuracy of Meters will be checked periodically by any authorized officer of BSNL and reserves the right to get the meter calibrated or checked at any time at his sole discretion and in the event of any error/fault in the meter being noticed, the bill for the journey undertaken (including those undertaken earlier) would be adjusted, besides any other penal action as decided by BSNL, which may even lead to termination of Contract.
- 8. **Miscellaneous Conditions:-** Service Provider should comply with the following:
 - (i) **Telephones-** Telephones, where requisition of vehicles can be conveyed all the 24 hrs. Telephone Numbers must be specified in the bid.
 - (ii) **Identity Cards-** Proper Identity Cards after verifying the antecedents of his drivers' thro' Local Govt. offices.
 - (iii) **Documents of vehicles-** The attested copy of R/C Book and the Insurance policy of vehicles supplied under this contract should be submitted to the authorized person of the BSNL and will be subject to scrutiny.
 - (iv) **Uniforms-** Provide his employees uniforms as required under the rules which shall be worn by them all the time while on duty.
 - (v) **Statutory Requirements** It is desirable to have the Registration with EPF, ESI Code, GST, PAN etc. However, if the Service Provider does not possess any or all the above, they should obtain the same if required by law to execute this service, within one month of commencement of Contract.
 - (vi) **Govt.Tax / Levy / Duty** other than GST for plying the vehicles in Shimla-SSA will be borne by the Service Provider.
 - (vii) **EPF and ESI** the bidder should have registration with EPF, ESI and GST authorities as per requirement. If the bidder is not required to register with authorities then, affidavit to this affect shall be attached along with technical bid.
 - (viii) **Parking / Toll Charges**, if any, may be claimed by Producing valid parking / Toll slips.
 - (ix) **Drivers** attested copy of driving license should be submitted during the contractual period.
 - (x) **Consumables** like lubricants, tyres, battery and repairs, maintenance, taxes, insurance, etc. will be to the Service Provider's liability.
 - (xi) **Assign** driving to only qualified experienced licensed drivers and also assume full responsibility for the safety and security of the officers/officials and store items.
 - (xii) The log book should be properly maintained by the owner/driver/staff on and should ensure that at the end of duty; they are completed and signed by the users for journey.
 - (xiii) **Vehicles Up-keep** shall be in good condition along with good and clean Seat covers & curtains. Vehicles so hired may be inspected by a pre-designated committee of BSNL officers with reference to good/properly maintained vehicle including cabin, upholstery, seats etc.
 - (xiv) **Unused KMs** if any during a particular month (monthly KM slabs) will be carried over to the subsequent three months and will be adjusted against any extra KMs if performed over and above the agreed slab for the hired vehicle. A Certificate to this effect is given on the body of bill while submitting claim for payment.

(xv) The transportation of Stores/Diesel within the SSA shall be arranged through hired vehicle for field formation as far as possible.

9. Debarring Conditions:-

- (i) No vehicle should be supplied having registration in the Name of employee of BSNL and a Certificate to this effect be given on the body of bill while submitting claim.
- (ii) The tampering of meter reading, vehicle usage timings, overwriting of Summary / Log Sheet and misbehavior of driver while on duty shall be viewed seriously, leading to even cancellation of contract.
- (iii) Service Provider shall not engage any person below 18 years of age.

10. BSNL will not have obligation:-

- (i) No liability whatsoever for payment of wages/salaries other benefits and allowances to his personnel that might become applicable under any Act or Order of the Govt. in this regard and the Service Provider shall indemnify BSNL against any/all claims which may arise under the provisions of various Acts, Government Orders etc. and any breach of such laws or regulations shall be deemed to be breach of this contract.
- (ii) No direct or indirect liability arising out of such negligent, rash and impetuous driving which is an offence under section 29 of IPC and any loss caused to BSNL have to be suitably compensated by Service Provider.
- (iii) Not be responsible for theft, burglary, fire or any mischievous deeds by his staff.
- (iv) Service Provider shall be the employer for his workers and BSNL will not be held responsible fully or partially for any dispute that may arise between the service provider and his workers.

11. Penalty for breach of terms & conditions:

- (i) In case of break down, after it's reporting for duty, the vehicles will have to be replaced by same type of vehicle immediately or not more than one hour. In case of nonavailability of suitable vehicle a penalty up to Rs. 200/- per breakdown may be imposed in addition to deduction on pro-rata basis for the period. If the number of break down exceeds three times in a month, a penalty of Rs.300/- per break down shall be imposed.
- (ii) The penalty for absence during extra Hour duty will be Rs.100 per occasion and for Temporary absence during duty hours without valid permission shall be Rs.75 per hour of absence.
- (iii) In case vehicle not provided by the contractor for any particular day penalty of Rs.500/per day shall be imposed in addition to deduction of hire charges on pro-rata basis for the period subject to maximum of 10% of the bill raised for that particular month. This clause will not be applicable if the contractor not supplies vehicle regularly for 15 days or more, in such cases the contract will be terminated for that particular vehicle and the performance security in respect of that vehicle will be forfeited.
- (iv) If the vehicle provided by the Service Provider is found to be not in good condition or without proper document; the vehicle may be rejected and sent back. No payment shall be made on account of such rejection. However in case of dispute the decision of GMTD Shimla would be final.
- (v) Should not refuse to provide vehicles against BSNL's requirement and on each refusal a penalty as given at item (iii) above will be deducted from the running bills besides any other action which may even lead to termination of contract.
- (vi) The Service Provider should provide the particular make & model of vehicle as agreed upon in the contract. The BSNL only reserves the right to substitute it with another similar vehicle. If for any reason whatsoever the BSNL is not happy with the condition of the vehicle provided, the Service Provider's nearest office will be informed immediately and they should accept any liability to replace it as per requirement. If for any reason the Service Provider is not in a position to provide a substitute vehicle as demanded by the BSNL then the BSNL will be free to engage a vehicle from the open market. The expenditure involved in such hiring shall be deducted from the due claim of the vendor and it will be in addition to the penalties under clause 11 (i) to (iii) of Section-III.

SECTION-IV GENERAL (COMMERCIAL) CONDITIONS

1. Bidder Eligibility:

- 1.1 The bidder should have minimum six months experience of providing vehicle to any agency Government / Public Sector or reputed Private Limited Companies / Firms. A certificate of satisfactory performance in similar services to this effect should be enclosed.
- 1.2 The bidder should have his own vehicles or on lease, At least one vehicle with insurance cover must be registered in his own name. All the vehicles should be registered as Commercial Vehicles with permit from RTO. Full details of the vehicle and a clear declaration that the firm will be able to supply commercial vehicles of model not older than January-2015 Model shall be provided.
- 1.3 The bidder should have the documents like PAN No, GST, EPF & ESI registration etc.
- as per details given in Annexure-II (Technical Bid).

2. Right to Accept or Reject:

BSNL shall not be bound to accept the lowest or any tender and reserves to itself the right to accept or reject any bid or to accept whole or a portion of tender, as it may deem fit, without assigning any reason thereof and without incurring any liability to the affected bidder(s) for the action of BSNL.

3. Bid Form.

- 3.1 The tender should be submitted in a **Single Cover** Superscribing **"Technical Bid"** of **"Tender for Hiring Vehicles for Shimla SSA"**. The envelope is to be duly sealed and addressed to **AGM (Planning) O/o GMTD BSNL Shimla.** The envelope must contain following documents in original:-
 - 1. EMD --- Bid Security
 - 2. DD of Tender Fee
 - 3. Power of Attorney and Authorization for executing the Power of Attorney.
 - 4. Integrity Pact (If applicable)
 - 5. Any affidavit submitted as per Technical Bid Form at **Annexure-II** of Tender Document.

The above envelope should be dropped in Tender Box in the O/o GMTD BSNL Shimla on scheduled date & time as per NIT.

- 3.2 Financial Bid as uploaded as per Section-V shall be opened separately. No indication of the Prices will be made in the Technical Bid.
- 3.3 Tender will be opened in the presence of Bidders present on the due date of opening. Technical Bids of the Tenders received will be opened. Time, Date and Venue of the opening of FINANCIAL BIDS will be intimated only to those Bidders, whose Technical Bid is accepted after evaluation of details and documents furnished in **Annexure-2**. No correspondence in this regard will be entertained. Incomplete Tender is liable to be rejected. All Columns should be furnished with relevant details and no column should be left blank.
- 3.4 Financial Bid of the selected bidders i.e. who qualify the technical bid, only will be opened electronically.
- 3.5 Bidder shall furnish the documents as per **Technical Bid Form at Annexure-2.**
- 3.6 Rates should be quoted as per the Schedule of Requirement & Hire Charges at **Section-V** and should be as per Financial Bid Form at **Annexure-1**. The format for Financial Bid should not be changed in any manner. Addition / deletion / alteration of the text will automatically render the tender invalid and therefore, will be summarily rejected.
- 3.7 The duly filled tenders must be accompanied with an EMD Demand Draft of requisite amount of the particular section for which the bidder is applying the bid and it should be drawn in favour of AO (Claim) O/o GMTD Shimla from any scheduled bank payable at Shimla.

3.8 Tender should be submitted online on or before scheduled date & time on the website http://www.tenderwizard.com/BSNL and all the uploaded documents except the price bid shall be dropped in a wax/tape sealed envelope in Tender Box at O/o GMTD Shimla by scheduled date & time.

3.9 The bidder is requested to examine all instructions, forms, terms and specification in the Bid documents. Failure to furnish all the information required as per Bid Documents or submission of the bids not substantially responsive to the Bid Documents in every respect will be at the bidder's risk and may result in rejection of the Bid.

3.10 A prospective bidder requiring any clarification on the Bid document shall notify the purchaser in writing. The purchaser shall respond in writing to any request for the clarification of bid document which it receives not later than 7 days prior to the date of opening of Tender.

3.11 At any time, prior to the date of submission of bid, BSNL may, for any reason whether at its own initiative or in response to a clarification required by a prospective bidder, modify the bid documents by amendments.

3.12 The amendments shall be notified in writing to all prospective bidders and these amendments will be binding on them.

3.13 The bidder shall bear all costs associated with the preparation and submission of the bid. BSNL in no case be responsible for these costs regardless of the conduct or outcome of the bidding process.

4. Bid opening

BSNL shall open the Technical bid cover containing documents detailed as per Clause (3.1) of Section-IV in the presence of bidders or their authorized representative who wish to be present at the time of opening of bids on due date. Authorization letter to this effect shall be submitted by the bidder before they are allowed to participate in bid opening (Format is given in Annexure-4). After scrutiny and evaluation of the Technical Bids, the BSNL will shortlist those who are eligible and the Financial Bid will be opened. The financial bid will be opened only in those cases that fulfill the eligibility conditions and furnish all documents as given in Technical Bid.

5. **Bid Evaluation**

5.1 **Financial Bids** shall be evaluated to determine whether they are complete, whether any computational errors have been made whether documents have been properly signed and whether bids are generally in order.

5.2 If there is a discrepancy between words and figures the amount in words shall prevail. Prior to detailed evaluation, BSNL will determine the substantial responsiveness of each bid to the bid document. A substantially responsive bid is one, which conforms to all the terms and conditions of bid documents without material deviation. A bid determined as substantially nonresponsive will be rejected by BSNL.

5.3 The procedure adopted for comparison of substantially responsive bids shall be on the **total cost of hire of the services for all types of vehicles** indicated in Scope of Work in **Section-II**, inclusive of all levies, taxes and charges as indicated in schedule at **Section V** of the bid document for particular section. L-1 bidder will be evaluated on the basis of lowest price quoted for hiring of vehicles for 2000 Km (Section-V).

6. Award of Contract

BSNL shall consider placement of letter of intent to those bidders whose offers have been found technically, commercially and financially acceptable. The bidder shall within 2 weeks of issue of letter of intent, give his acceptance along with performance security in conformity with **clause 17 of Section-IV** and as per format shown in **Annexure-3** of bid document.

7. Right to vary quantities

- 7.1 BSNL reserves the right to increase or decrease up to one vehicle per section of the required quantity of services specified in the schedule of requirements without any change in hiring charges of the offered quantity and other terms and conditions.
- 7.2 BSNL reserves the right to extend the tender for one year on the same terms and conditions as per bid document, the rates/hire charges will remain same and it will have binding upon the bidder.
- 7.3 With the increase in numbers of the hired vehicles or in case of extension of tender (up to one year) the cost of tender will increase proportionally.

8. Signing of Contract

8.1 Signing of Agreement shall constitute the award of hiring contract on the bidder.

8.2 Upon the successful bidder furnishing the Performance Security the BSNL shall discharge its bid security in pursuant to **Clause 12**.

8.3 On signing the agreement & furnishing of the performance security the bidder has to provide the details of the vehicles (Model, Registration Numbers, Vehicle type etc.) which he is going to provide to the BSNL along with the all documents necessary as mention in the bid document within seven days.

9. Annulment of Award

Failure of the successful bidder to comply with the requirement of **Clause 8** shall constitute sufficient ground for the annulment of the award and forfeiture of the bid security in which event BSNL may make the award to any other bidder at the discretion of BSNL or call for new bids.

10. **Period of validity of bids**

(i) The bid shall remain **valid for 150 days** after the date of opening of bids. A bid valid for a shorter period shall be rejected by BSNL as non-responsive.

(ii) A bidder accepting the request of BSNL for an extension to the period of bid validity, in exceptional circumstances, will not be permitted to modify his bid.

11. Bid Price.

11.1 The supplier shall quote price as per schedule given in **Section V** for all types of Vehicles given in the schedule of requirement. The composite price should include all the type of Taxes, excluding GST as applicable from time to time. However, the basic unit price needs to be individually indicated against the supply under the contract.

11.2 The price quoted by the bidder shall remain fixed during entire period of Contract & shall not be subject to variation on any account. A Bid submitted with an adjustable price quotation will be treated as non-responsive and rejected.

11.3 "Discount" or extra charges if any mentioned by the bidders shall not be considered unless these are specifically indicated in the price schedule.

12. Bid Security

12.1 Pursuant to Clause 3.7 of Section-IV, the bidder must deposit EMD for the requisite amount as mentioned in the NIT. The Bid Security shall be in the form of Demand Draft for the requisite amount as mentioned in the NIT of the particular division for which the bidder is applying /bidding and it should be drawn in favour of AO (Claim) O/o GMTD Shimla from any scheduled bank payable at Shimla.

12.2 The successful bidder's EMD will be discharged upon the bidder's acceptance of the award of contract satisfactorily in accordance with **Clause 17 of Section-IV** and furnishing the performance security.

13. The Bid Security may be forfeited:

- 13.1 If bidder withdraws his bid during the period of bid validity specified by the bidder in the bid form.
- 13.2 If the successful bidder fails
 - i) to sign contract in accordance with Clause 8
 - ii) to furnish performance security in accordance with clause 17 of Section IV
 - iii) A bid not secured in accordance with Para 11.1 shall be rejected by the BSNL as Non-responsive at the bid opening state and returned to the bidder unopened.
 - iv) The bid security of unsuccessful bidder will be discharged / returned as early as possible but not later than 30 days after the expiry of the period of bid validity.

14. Terms of Payment:

14.1 The payment shall be made on monthly basis. Monthly bills i.r.o vehicles engaged on monthly basis shall be submitted in duplicate to the authority specified in contract along with the photo copies of the log book duly signed, checked & verified by the user & controlling officer of the user of the vehicle by the 5th of the following month for payment. The copy of GST paid Challan for the previous month / quarter as the case may be should be produced along with the bills for payment. In case, the bills are not submitted to BSNL as per above schedule, BSNL will not take responsibility for delay in payment. If the bill is received after three months of its becoming due, it must be accompanied with the sufficient justification/reasons for delay and the GMTD Shimla reserves the right to reject such cases as time barred.

14.2 The triplicate copy of the bill will be returned to the Service Provider duly receipted. The bills should be sent to BSNL for payment vehicle-wise. It should be ensured that there is no overwriting on the log books and on the bills. In no case, the bills without signature and copy of log book without certificate by the users and controlling officer will be accepted for payment and if it is found so, the amount will be disallowed.

14.3 In case the vehicle engaged / discontinued in between of the month the contractor shall be paid for the numbers of days for which the vehicle was used. The daily rate shall be calculated by dividing the monthly rate by thirty (30). Also monthly kilometers will be worked out on proportionate basis.

- 14.4 GST is payable extra, as applicable from time to time.
- 14.5 GST No & PAN number should be printed on bill form of contractor.
- 14.6 If the firm is registered with EPF & ESI , the photocopy of Challan as proof of deposit of EPF & ESI contribution to be endorsed with bill.
- 14.7 Checklist Points (To be endorsed on the bill): Contract specifications bearing No.....dated.... Bill No. dated
 - (i) Work has been done satisfactory as per contract bearing Number...... date......
 - And further w/o Number......date for the period
 - (ii) All documents have been attached as required as per contract.
 - (iii) All statutory obligations as per Labour Law have been compiled by the Contractor.
 - (iv) No complaints received against contractor.
 - (v) Nothing is due from contractor.
 - (vi) No damages done by the contractor during performance of duty.
 - (vii) No penalty is applicable as per contract.

15. Clause by clause compliance.

A clause- by – clause compliance of service to be provided shall be given as per Scope of Work U/S II and General & Commercial Conditions U/S-IV. In case of deviation a statement of deviation shall be given.

16. Duration / Period of Contract:

Normally contract will be awarded for 1 (one) year from the date of execution of the agreement. However, extension for the next year/part thereof will be considered by the competent authority (GMTD BSNL Shimla) keeping in view the various factors, such as prevailing market price, satisfactory performance of the firm, written consent of the contractor to carry out the work during the extended period on same terms & conditions of the contract.

17. Performance Security:

17.1 The successful bidder shall be required to deposit an amount equal to 10% of the contract value subject to maximum limit of Rs 5 lakhs within 2 weeks of conveying BSNL's intention for accepting the bid as Performance Security.

17.2 Performance Security shall be submitted in the form of Bank Guarantee issued by a scheduled Bank and the Performa provided in **Annexure-3** of the bid document.

17.3 The bank Guarantee should be valid for 18 (Eighteen) months from the date of the signing of hiring agreement.

20. Insurance

24. Arbitration:

- In the event of any question, dispute or difference arising under this agreement or in 1 connection there-with except as to matter the decision of which is specifically provided under this agreement, the same shall be referred to sole arbitration of the Chief General Manager, (Himachal Pradesh) or in case his designation is changed or his office is abolished then in such case to the sole arbitration of the officer for the time being entrusted whether in addition to the functions of the Chief General Manager, (Himachal **Pradesh**) or by whatever designation such officers may be called (hereinafter referred to as the said officer) and if the Chief General Manager, (Himachal Pradesh) or the said officer is unable to act as such to the sole arbitration or some other person appointed by the Chief General Manager, or the said officer. The agreement to appoint an arbitrator will be in accordance with the Arbitration and Conciliation (Amended) Act 2015. There will be no objection to any such appointment that the arbitrator is BSNL Servant or that he has to deal with matter to which the agreement relates or that in the course of his duties as BSNL Servant has expressed view on all or any of the matter under dispute. The award of the arbitrator shall be final and binding on the parties. In the event of such arbitrator to whom the matter is originally referred, being unable to act for any reasons whatsoever such Chief General Manager or the said officer shall appoint another person to act as arbitrator in accordance with terms of the agreement and the person so appointed shall be entitled to proceed from the stage at which it was left out by his predecessors.

It is anticipated that the Service Provider will supply vehicles to these authorities on regular basis until such time the contract is valid and the parties in agreement are satisfied with the performance of the contract.

4. Service Provider will have no objection in any such appointment that arbitrator so appointed is an employee of BSNL or a Government Servant or that he has to deal with the matter to which the agreement relates or that in the course of his duties as a BSNL employee he has expressed his views on all or any of the matters in dispute. The adjudication of such Arbitrator shall be governed by the provisions of the Arbitration and Conciliation Act 1996, or any statutory modification or re-enactment three of or any rules made thereof.

The venue of Arbitration proceeding shall be Office of * _____ of BSNL at _____ or such other place as the arbitrator may decide.

(N.B : At the places marked * in the above clauses, "The Chief General Manager (CGM) / Principal General Manager (PGM) / Telecom District Manager (TDM), as the case may be incorporated.)

24. If the Service Provider institutes any legal proceedings against the BSNL to enforce any of its rights under this agreement it shall be in the legal jurisdiction of BSNL where the vehicle has been hired and not the place where the Service Provider has his registered office.

25. The Service Provider is / shall be responsible for compliance of all the laws / rules/ regulations and Government instructions that are/ will be applicable to and aimed to protect the interest of the employees/ workers engaged by it and shall ensure payment of all the statutory dues/ liabilities as may have arisen during the past 'or' may arise during the course of performance of this contract.

26. Notwithstanding anything contained in the Bid Document, the successful bidder shall have to furnish an unequivocal and unqualified undertaking / declaration to indemnify BSNL in the proforma annexed as Appendix –III duly attested by a Magistrate / Executive Magistrate.
