## 1. BID Security /EMD:

bidder shall furnish the bid EMD in one of the following ways:-

- c) Bank Guarantee from a scheduled bank drawn in favour of Accounts Officer (Claim) O/o GMTD BSNL

Shimla which should be valid for 210 days from the tender opening date.

The MSE units shall be exempted from submission of Bid Security /EMD deposit on production of requisite proof in respect of valid certification from MSME for the tendered item

#### 2. ELIGIBILITY Condition: -

Average Annual financial turnover (to be submitted along with balance Sheet certified by CA) during the last 3 years i.e. 2019-20, 2020-21 & 2021-22 should be at least 30% of the annual estimated cost of Tender(Total estimated cost of tender divide by tender period in year).

Tenderer should have experience of repairing and maintenance of SMPS based Power plants or similar in BSNL/MTNL/DOT/Govt PSU/Govt Dept or in any License Telecom service provider, during last 7 (Seven) financial years & current year (i.e. should not older than 01-04-2015) ending last day of the month previous to the one in which applications are invited should be either of the following:-

Three similar completed works each costing not less than amount equal to 40% of the annual estimated cost of the tender. (Total estimated cost of the tender divide by tender period in year).

O R

Two similar completed works each costing not less than amount equal to 50% of the annual estimated cost of the tender ( Total estimated cost of the tender divide by tender period in year) .

OR

One similar completed work costing not less than amount equal to 80% of the annual estimated cost of the tender (Total estimated cost of the tender divide by tender period in year).

Experience Certificate should be issued by the officer not below the rank of Divisional Engineer/STS or equivalent, in case of BSNL/MTNL/DOT/Govt. PSU/Govt. Department and by purchase order/work order issuing authority, in case of license telecom service provider. Bids without EMD, eligibility criteria documents & cost of tender (in case downloaded) shall be summarily rejected. All documents must be self attested.

- **3.** If there is any doubt / mismatching in instructions in this tender related to offline / online (e-tender) procedure, instruction related to e-tender will be valid and final.
- **4.** This is an e-tender hence bidders may participate through online process (e-tendering) in this tender. E-tender website will be www.etenders.gov.in.
- **5.** The bidder is required to submit the required Off-line documents in the tender box. In the case where no off-line document is received the bid will be rejected.
