## 2. ELIGIBILITY CRITERIA

# The Contractors satisfying the following conditions: -

Average annual turnover during the last 3 years, ending 31<sup>st</sup> March of the previous financial year, should be at least **Rs. 4,98,420/-**.

### AND

SINL enlisted contractors in Electrical category of Class-II or above.

### OR

- Experience of having successfully completed similar works (Comprehensive Maintenance and Operation of Electro - mechanical services) in BSNL comprising of either substation or air conditioning service as part of scope of work during last 7 years ending last day of month previous to the one in which applications are invited, should be either of the following :-
- Three similar successfully completed works costing not less than the amount equal to Rs. 6,64,561/-.

OR

Two similar successfully completed works costing not less than the amount equal to Rs. 9,96,841/-.

#### OR

- One similar successfully completed work costing not less than the amount equal to Rs. 13,29,121/-.
- The Contractor shall have to possess a valid ELECTRICAL LICENCE of appropriate Voltage Issued by any State Govt. Under Clause 45 of compilation of Indian Electricity Rules 1956 or as amended from time to time, provided notification in official Gazette, exempt, on such condition.

The contractor shall also submit and confirm:
