Eligibility Conditions

The Contractors satisfying the following conditions: -

• BSNL enlisted contractor in Electrical category III (E) and above.

OR

• The Contractors satisfying the following conditions: -The contractor enlisted in CPWD, M.E.S. and Railways in respective class as per their tendering limits.

AND

Average annual turnover during the last 3 years, ending 31st March of the previous financial year, should be at least **Rs. 3,83,571/-**

AND

Experience of having successfully completed similar works in Central Government/State Government /Central Autonomous Body/Central Public Sector Undertaking during last 7 years ending last day of month previous to the one in which NIT applications are invited, should be either of the following :-

- ➤ Three similar successfully completed works costing not less than the amount equal to Rs. 85,238/-OR
- > Two similar successfully completed works costing not less than the amount equal to Rs. 1,27,857/-

OR

- > One similar successfully completed work costing not less than the amount equal to Rs. 1,70,476/-
- The Contractor shall have to possess a valid ELECTRICAL LICENCE of appropriate Voltage Issued by any State Govt. Under Clause 45 of compilation of Indian Electricity Rules 1956 or as amended from time to time, provided notification in official Gazette, exempt, on such condition.
