### 1. <u>Eligibility Conditions</u>

The Contractors satisfying the following conditions:

Average annual turnover during the last 3 years, ending 31stMarch of the previous financial year, should be at least Rs.8,50,622/-.

**AND** 

BSNL enlisted contractors in Electrical category I(E) and above.

OR

Experience of having successfully completed similar works of mobile towers with licensed operators during last 7 years ending last day of month previous to the one in which applications are invited, should be either of the following:

Three similar successfully completed works costing not less than the amount equal to Rs.11,34,163/-.

OR

Two similar successfully completed works costing not less than the amount equal to Rs.17,01,244/-

OR

One similar successfully completed work costing not less than the amount equal to Rs. 22,68,326/-

OR

- The manufacturer/authorized dealer/OEM of any of the makes of major equipment (DG sets) included in the NIT. The letter of authorization from manufacturer in original/photocopy attested by BSNL Executive will be submitted
- Similar works: O&M of electromechanical services having DG sets or repair and maintenance of DG sets.

The contractor shall also submit and confirm:

- Documentary proof of satisfying the eligibility conditions as per "1" above, copy of PAN card, copy of CA certificate for turnover, Original authorization of person quoting the tender from Directors/ Proprietor of the company, Near relative certificate from or on behalf of Directors/ Proprietor of the company.
  - (All the documents shall be self attested / certified by any BSNL Executive /Notary /Gazetted Officer of Central Govt).
- ➤ The firm should be registered under the Himachal Pradesh Value Added Tax Act 2005 and should further have EPF and ESI registration certificates from appropriate Govt. authorities.
- The firms who claim to be exempted from the ESI & EPF registration need to submit an affidavit on Non-judicial stamp paper for the same as per performa at **p.no.40** (Annexure–IV).
- ➤ If the firms do not have ESI & EPF registration, they will though be allowed to participate in the bid process, but they will have to get the ESI & EPF registration within15 days from the date of issue of intimation from BSNL regarding intent to accept the tender, else their EMD shall be forfeited absolutely and the firm shall not be allowed to participate in the next tender for the same work. If the firm fails to produce ESI & EPF registration certificate on more than one occasion, the firm shall be barred from participating in all future tenders.
- The contractor who are not registered under Himachal Pradesh Value Added Tax Act 2005 may bid for the contract however such contractors will have to get himself registered within 15 days from the date of issue of intimation from BSNL regarding intent to accept the tender, else their EMD shall be forfeited absolutely and the firm shall not be allowed to participate in the next tender for the same work. The firm shall give an affidavit as per performa at **page no.41** (Annexure-V) in this regard.
- The Firm should have valid service tax registration.
