Tenders, which should always be placed in sealed envelope, in the manner detailed at Para no.5.0 above, will be received and opened on the due dates in BSNL, Electrical Sub Division, BSNL CSC Building Dharamshala H.P. 176215 up to 15:00 Hrs& 15:30 Hrs. respectively by Executive Engineer (E) or his authorized representative in his office.

Envelope-I containing earnest money, tender cost and documents pertaining to eligibility etc. (As per clause 5.3 above) shall be opened first on the due date.

In case Envelope-I is not annexed or tender cost, EMD, Eligibility documents etc. not found in proper form, the Envelope-II containing tender documents will not be opened at all and such unopened tender shall be returned on spot to the bidder or his representative during the process of opening of

Every page of downloaded tender shall be signed by the tenderer with stamp (seal) of his firm/organization and the tenderer shall furnish a declaration" that No addition/ deletion/ correction have been made in the tender document, submitted and it is identical to the tender document appearing on website.(In case of the downloaded tender documents from the internet)".

If it is found at any stage of tender scrutiny after submission of tender that the bidder has made any correction/addition/alternation/omission in tender documents vis-à-vis tender documents available on the website/original draft NIT in office, the bid shall be treated as non responsive and shall be summarily rejected and the EMD deposited by tenderer shall be forfeited in addition to any other action as per prevalent rules.

The conditional tender or tenders with conditional rebate shall be summarily rejected. However tenders with unconditional rebate will be considered.

Performance guarantee:

The successful tenderer shall upon issue of letter of tender acceptance, shall be required to furnish irrevocable performance guarantee for an amount equal to 5% of the contract value in the form of CDR/FDR/DD/ Bank Guarantee (Annexure-III to the tender documents) within 5 DAYS from the date of issue of acceptance of tender by the BSNL. In the event of failure on the part of the successful tenderer to furnish the performance guarantee within 5 DAYS, the earnest money deposited (EMD) will be forfeited and tender shall be cancelled.

The Notice Inviting Tender shall form part of the contract document, In accordance with clause-1 of the contract, the tender acceptance letter shall be issued first in favour of the successful tenderer r/contractor. The contract shall be deemed to have come into effect on issue of communication of acceptance of the tender. On such communication of acceptance, the successful tenderer/ contractor shall within 5 DAYS from such date, formally sign the contract that includes all relevant documents.

The Notice Inviting Tender, all the documents including additional conditions, specifications and drawings, if any, forming part of the tender and as issued at the time of invitation of tenders and acceptance thereof together with any correspondence leading thereto Agreement shall be drawn with the successful tenderer on prescribed standard Form No. B.S.N.L.W.-8 which is available as a B.S.N.L. Publication, Tenderer shall quote his rates as per various terms and conditions of the said form which will form part of the agreement

Tenderers are advised to inspect and examine the site and its surrounding and satisfy themselves before submitting their tenders as to the nature of the ground and the form and nature of the site, the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their tender. A tenderer shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charges consequent on any misunderstanding or otherwise shall be allowed. The tenderer shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity, access facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of tender by a tenderer implies that he has read this notice and all other contract documents and has made himself aware of the scope and

specifications of the work to be done and of conditions and local conditions and other factors having a bearing on the execution of the work. The competent authority on behalf of the BSNL does not bind himself to accept the lowest or any other tender, and reserves to himself the authority to reject any or all of the tenders received without the assignment of a reason. IMPORTANT NOTE FOR CONTRACTORS

The contractor shall read carefully the following conditions and shall quote accordingly.

1.0 Tax and Duties:-

1.1 All taxes, Levies, duties etc. in respect of this contract **(i/c service tax)** payable by the Vendor & BSNL will not entertain any claim in respect of the same.

1.2 BSNL shall deduct statutory taxes and duties like income tax, works contract tax etc. from payment due to the firm as per rule of the State. Central Government. The Accounts Officer of the concerned SSA shall issue certificates for such deductions to the firm.

1.3 As per Govt. of India Service Tax (Determination of Value) Rules 2006, Service Tax for Original works is applicable on 70% of the total amount charged for the works contract. At present, the rate of Service Tax is @ 15% and shall be applicable as being modified by Govt. Of India time to time.

2.0 Work Contract Tax:-

The rates offered by the firm shall be inclusive of the works contract tax as applicable in the state. 7.0 EARNEST MONEY DEPOSIT:

- 7.1 **Validity period:** The validity period of Earnest Money deposit should be kept 30 days beyond the Tender validity i.e. 90+30=120 days, as the tender validity period is 90 days.

- 3 The Engineer-in charge or the duly authorized representative, at the site work, will give the layout of the work.
- 4 The following wiring shall be done in separate circuits.

- 10 The outlet box is for switches and pipes or conduits etc. For different categories of conduits runs catering for different type of electric wiring as mentioned in clause(4) above shall be painted inside with different colors each signifying the different categories mentioning so as to avoid mixing of various circuits and their wiring and nothing extra will be paid for this account.
- 11 At the time of laying conduit pipe in the slab and in recess the contractor will keep fish wire of 14 S.W.G. (G.I.) wire through conduit/pipe and will have to take special care so that the conduits do not pass through air conditioning nuts grills, columns, beams etc. If any such necessity is foreseen special written permission of E.E.
