Separate D.D. should be attached for tender fee & EMD.

ii. Second envelope shall contain duly filled tender document.

The same shall be clearly written on the envelopes.

The 1st envelope containing Tender fee, attested documents proving fulfillment of eligibility Criteria & EMD in proper form shall be opened first..

In case: -

(i) Tender fee is not submitted in proper form. (ii) EMD is not in proper form.

(iii) Firm fails to fulfill eligibility criteria on the basis of document submitted in first envelop.

(iv) The performance of tenderer is not found satisfactory.

The second envelope shall not be opened.

If the day of opening of the tender declared as a Holiday then the tender will be opened on the next working day. The tenders shall neither be issued nor received through POST / COURIER. CONDITIONAL TENDERS OR TENDERS WITH CONDITIONAL REBATES SHALL BE SUMMARILY REJECTED.
