The manufacturer/ authorized dealer/ authorized service dealer / OEM of any of the makes of BSNL approved EA sets (Ashok Leyland /Cummins/ Cater pillar /KOEL / Volvo Penta / Mahindra & Mahindra (up to 200 KVA) /Escorts (up to 30 KVA)/ Eicher (up to 35 KVA)). The letter of authorization from manufacturer in original / photocopy attested by BSNL Executive will be submitted.

OR

Experience of having successfully completed similar works in BSNL during last 7 years ending last day of month previous to the one in which applications are invited.

Followings self certified copies of Documents to be submitted along with quotation:

1. Documentary proof of satisfying the eligibility conditions as above
2. Valid GST Registration as per GST Law (SGST/CGST/IGST as applicable)

3. Pan Number (Permanent Account Number)

Specification

1. The work shall be done as per the specification of department.
2. Time allowed for completion of work shall be **15 Days** from the date of issue of work order.
3. The rates offered by the firm shall be inclusive of the GST as applicable. The firm shall claim GST with the bill clearly furnishing the complete details of GST so included. BSNL, under no circumstances, will consider any claim of GST not included in the bill. It will be the firm's responsibility to settle GST with GST authorities.
4. The agency will provide the workers with necessary Tools & Plant, Testing and safety equipments.
5. The work shall be supervised by the qualified Engineer-in-charge or his duly authorized Representative, at the site of work.
6. The layout of the work will be given by the Engineer-in-charge or his duly authorized representative at the site of work.
7. Any damage done to the building by the contractor during the execution of work shall be made good by the contractor at his risk and cost, if the damage are not made good by the contractor in reasonable time determine by the Engineer-in-charge the same will be got done at his cost departmentally after serving notice to him.
8. No extra payment will be made for any kind of transportation.
9. The spare parts used should be from the genuine spare parts manufacturers. Documantry proof of same shall be submitted.
10. The mobile oil of the DEA set shall be changed as per manufacturer's recommendation.
11. The firm shall clean the DEA set after repairs.
12. The firm shall top up the battery electrolyte without any extra cost. Check& correct cooling water level & lube oil level if required
13. The firm shall check state of batteries, terminals for cleanliness & level of water with out the extra cost.

NOTE:-The replacement of material shall be with the same rating and make as that of the original.
