ELIGIBILITY CRITERIA

The Contractors satisfying the following conditions: -

- ❖ BSNL enlisted contractor in Electrical category IV (E) and above.

OR

- ❖ The Contractors satisfying the following conditions: -

The contractor enlisted in CPWD, M.E.S. and Railways in respective class as per their tendering limits.

AND

- ❖ Average annual turnover during the last 3 years, ending 31st March of the previous financial year, should be at least **Rs. 54,511/-**

AND

- ❖ Experience of having successfully completed similar works in Central Government/State Government /Central Autonomous Body/Central Public Sector Undertaking during last 7 years ending last day of month previous to the one in which NIT applications are invited, should be either of the following :-

- Three similar successfully completed works costing not less than the amount equal to **Rs. 72,682/-**
OR
- Two similar successfully completed works costing not less than the amount equal to **Rs. 1,09,022/-**
OR
- One similar successfully completed work costing not less than the amount equal to **Rs1,45,363/-**

- ❖ The Contractor shall have to possess a valid ELECTRICAL LICENCE of appropriate Voltage Issued by any State Govt. Under Clause 45 of compilation of Indian Electricity Rules 1956 or as amended from time to time, provided notification in official Gazette, exempt, on such condition.

1. The intending Tenderer must read the terms and conditions of tender document, BSNL EW-6 & EW-8 carefully which can be accessed from web site <https://eprocure.gov.in/epublish> or www.hp.bsnl.co.in. He should only submit his tender if he considers himself eligible and he is in possession of all the documents required.
2. The intending bidders must have valid Class-III digital signature to submit e-Tender.
3. The e-Tender will be submitted online in two Electronic Envelope systems.
 - ❖ Electronic Envelope No-I: - Eligibility documents & Technical Bid (e-Tender).
 - ❖ Electronic Envelope No-II: - Price Bid.
4. Tender Cost, EMD & other documents are required to be submitted offline in the prescribed form in the o/o Executive Engineer (Elect.), BSNL Electrical Division, **First Floor, Block no. 35, SDA Complex, Kasumpati, Shimla-171009** up to the Last date and time of submission of EMD, Tender Cost & Other documents. 5. Cost of Bid Document/Tender cost – Tender cost amounting Rs.590/- (**Including GST**) can be deposited in the account details as below or can be submitted in the form of DD drawn in favour of **AO (Claim Officer), O/o GMTD Shimla** payable at Shimla.

 Proof of tender cost submission in the account shall be submitted while uploading tender cost document during tendering.
6. On Line e-Tender can only be submitted after uploading following valid scanned documents (**i.e. e-Envelope-I**) related to eligibility conditions as per **point no-1** above up to **Last date and time of online submission/ uploading of E-tender i.e. e-Envelope - I& II**.
 - i. Documentary proof of satisfying the eligibility conditions as per **1 above** (Work completion certificate etc as required)
 - ii. CA certificate towards turn over & deposition of income tax.
 - iii. PAN Card.
 - iv. Valid GST Registration as per GST Law (SGST/CGST/IGST as applicable) certificate.
The contractors who are not having Valid GST Registration as per GST Law (SGST/CGST/IGST as applicable), may bid for the contract however such contractors will have to get themselves registered within 15 days from the date of issue of intimation from BSNL regarding intent to accept the tender, else their EMD shall be forfeited absolutely and the firm shall not be allowed to participate in the next tender for the same work. If the firm fails to produce Valid GST Registration as per GST Law (SGST/CGST/IGST as applicable) certificate on more than one occasion, the firm shall be barred from participating in all future tenders. The firm shall give an affidavit as per draft on page no.16 in this regard.
 - v. EPF and ESI registration certificate.
The contractors who are not having EPF & ESI registration, may bid for the contract however such contractors will have to get themselves registered within 15 days from the date of issue of intimation from BSNL regarding intent to accept the tender, else their EMD shall be forfeited absolutely and the firm shall not be allowed to participate in the next tender for the same work. If the firm fails to produce EPF & ESI registration certificate on more than one occasion, the firm shall be barred from participating in all future tenders. The firm shall give an affidavit as per draft on page no.16 in this regard

 - viii. Demand draft towards Cost of Tender documents as per **Para 6** of EW-08.
 - ix. EMD/Bid security in prescribed form as per **Para 7 of EW-08.**
 - x. Integrity Pact
 - xi. Self-declaration by the firm for not blacklisted by GST authorities and mentioning of multiple GST numbers, if available.
7. Validity of tender shall be for 90 days from the date of opening of tender.
8. The bidding process will be accepted only through e-Tendering platform. As tenders are invited through e-Tendering process, physical copy of the tender document would not be available for sale. Contractor can upload documents in the form of JPG format, PDF format and any other format as permissible by the e- tendering portal.
9. For e-Tendering of this tender BSNL has engaged e-portal maintained by M/s NIC @ **website www.eprocure.gov.in**.The agency intending to participate in tendering process shall have to register with them. For any further query regarding tender uploading/downloading, Helpdesk of **M/s NIC** may be contacted. **A user manual for vendor (bidder) is also available.**
