

## NOTICE INVITING TENDER

The Sub Divisional Engineer (E) B.S.N.L., Electrical, Sub Division, MTE Nahan invites on behalf of Bharat Sanchar Nigam Limited sealed item rate tenders for the work from the eligible contractors satisfying the following conditions as given below :-

### **Eligibility Conditions**

The Contractors satisfying the following conditions:

Average annual turnover during the last 3 years, ending 31<sup>st</sup> March of the previous financial year, should be at least 30% of the estimated cost put to tender.

And

**BSNL enlisted contractor in Electrical category IV (E) and above.**

OR

The manufacturer/authorized dealer/OEM of any of the makers of major equipment included in the NIT. The letter of authorization from manufacturer in original/photocopy attested by BSNL Executive will be submitted.

OR

Experience of having successfully completed similar works in BSNL during last 7 years ending last day of month previous to the one in which applications are invited, should be either of the following

Three similar successfully completed works costing not less than the amount equal to equal to 40% of the estimated cost put to tender.

OR

Two similar successfully completed works costing not less than the amount equal to equal to 60% of the estimated cost put to tender.

○ OR

One similar successfully completed work costing not less than the amount equal to equal to 80% of the estimated cost put to tender.

The contractor shall also submit and confirm:

- Documentary proof of satisfying the eligibility conditions as per 1 above
- CA certificate towards turn over /deposition of income tax & PAN Card
- **Valid GST Registration as per GST Law (SGST/CGST/IGST as applicable) certificate.**

The contractors who are not having Valid GST Registration as per GST Law (SGST/CGST/IGST as applicable), may bid for the contract however such contractors will have to get themselves registered within 15 days from the date of issue of intimation from BSNL regarding intent to accept the tender, else their EMD shall be forfeited absolutely and the firm shall not be allowed to participate in the next tender for the same work. If the firm fails to produce Valid GST Registration as per GST Law (SGST/CGST/IGST as applicable) certificate on more than one occasion, the firm shall be barred from participating in all future tenders. The firm shall give an affidavit as per draft on page no.6 in this regard.

- **EPF and ESI registration certificate.**

The contractors who are not having EPF & ESI registration, may bid for the contract however such contractors will have to get themselves registered within 15 days from the date of issue of intimation from BSNL regarding intent to accept the tender, else their EMD shall be forfeited absolutely and the firm shall not be allowed to participate in the next tender for the same work. If the firm fails to produce EPF & ESI registration certificate on more than one occasion, the firm shall be barred from participating in all future tenders. The firm shall give an affidavit as per draft on page no.7 in this regard.

- Declaration of EW-6 / EW-8, Relative Certificate & Undertaking -I & II by contractors **(As per draft on page no.5)**
- Tender Cost & EMD in prescribed form.

All the documents shall be self attested / certified by any BSNL/MTNL Executive /Notary /Gazetted Officer of Central Govt.)

Validity of tender shall be for 90 days from the date of opening of tender.

The tenders of contractors who do not deposit earnest money in the prescribed manner (in separate

Cover) are liable to be rejected and will not be opened.

The firm who quotes on the tender downloaded from web-site shall strictly follow the following Procedure:-

The tender shall be submitted in two envelope system.

- First envelope shall contain tender application (If tender downloaded from Web), tender fee, attested documents (self attested and counter attested by any executive of BSNL/MTNL or Gazetted officer of GOI; otherwise all originals of eligibility criteria shall be produced for verification at the time of tender opening) proving fulfillment of eligibility criteria as per the tender notice & EMD in proper form. Separate D.D. should be attached for tender fee & EMD.
- Second envelope shall contain duly filled tender document.

The same shall be clearly written on the envelopes.

The 1st envelope containing Tender fee, attested documents proving fulfillment of eligibility Criteria & EMD in proper form shall be opened first..

In case: -

1. Tender fee is not submitted in proper form. (ii) EMD is not in proper form.
2. Firm fails to fulfill eligibility criteria on the basis of document submitted in first envelop.
3. The performance of tenderer is not found satisfactory.

The second envelope shall not be opened.

If the day of opening of the tender declared as a Holiday then the tender will be opened on the next Working day. The tenders shall neither be issued nor received through POST / COURIER. CONDITIONAL TENDERS OR TENDERS WITH CONDITIONAL REBATES SHALL BE SUMMARILY REJECTED. If any difference/ discrepancies found between down loaded Tender form, any hard copy issued from Division Office, the contents in Draft NIT issued from this or higher offices will be final & binding.
