1. ELIGIBILITY CRITERIA

The Contractors satisfying the following conditions: -

- ❖ Average annual turnover during the last 3 years, ending 31st March of the previous financial year, should be at least **Rs. 3,26,578/-**.
- AND**
- ❖ BSNL enlisted contractors in Electrical category of Class-II or above.
- OR**
- ❖ Experience of having successfully completed similar works (Comprehensive Maintenance and Operation of Electro - mechanical services) in BSNL comprising of either substation or air conditioning service as part of scope of work during last 7 years ending last day of month previous to the one in which applications are invited, should be either of the following :-
- Three similar successfully completed works costing not less than the amount equal to **Rs. 4, 35,437/-**.
- OR**
- Two similar successfully completed works costing not less than the amount equal to **Rs. 6, 53,155/-**.
- OR**
- One similar successfully completed work costing not less than the amount equal to **Rs. 8, 70,874/-**.
- ❖ The Contractor shall have to possess a valid ELECTRICAL LICENCE of appropriate Voltage Issued by any State Govt. Under Clause 45 of compilation of Indian Electricity Rules 1956 or as amended from time to time, provided notification in official Gazette, exempt, on such condition.
2. The intending Tenderer must read the terms and conditions of tender document, BSNL EW-6 & EW-8 carefully which can be accessed from web site www.etenders.gov.in or www.hp.bsnl.co.in. He should only submit his tender if he considers himself eligible and he is in possession of all the documents required.
 3. The intending bidders must have valid Class-III digital signature to submit e-Tender.
 4. The e-Tender will be submitted online in two Electronic Envelope system.
 - Electronic Envelope No-I: - Eligibility documents & Technical Bid (e-Tender).
 - Electronic Envelope No-II: - Price Bid.

Tender Cost, BSD & other documents are required to be submitted offline in the prescribed form in the o/o **The Executive Engineer (Elect.), BSNL Electrical Division, Head Post Office Complex, BSNL CSC Bldg., Dharamshala-176215 Email : eebsnldma@gmail.com** up to the Last date and time of submission of Tender Cost & Other relevant documents. 6. On Line e-Tender can only be submitted after uploading following valid scanned documents (i.e. e-Envelope-I) related to eligibility conditions as per point no-1 above up to Last date and time of online submission/ uploading of E-tender.
- ❖ Documentary proof of satisfying the eligibility conditions as per 1 above.
 - ❖ CA certificate towards turn over / deposition of income tax & copy of PAN Card.
 - ❖ GST registration certificate.
 - ❖ EPF and ESI registration certificate.
 - ❖ Declaration of EW-6 / EW-8, Relative Certificate & Undertaking -I & II by contractors. (As per draft on page no.18).
 - ❖ Tender Cost & Bid Security Declaration in prescribed form.
 - ❖ Original authorization of person quoting tender from Directors/ Proprietor of company.
 - ❖ The Integrity Pact (As per draft on page no.19 to 22.agreement shall be executed in Rs 100/- non judicial stamp paper)
7. Validity of tender shall be for 90 days from the date of opening of tender.
8. The bidding process will be accepted only through e-Tendering platform. As tenders are invited through e-Tendering process, physical copy of the tender document would not be available for sale. Contractor can upload documents in the form of JPG format, PDF format and any other format as permissible by the e-tendering portal.
