

## **NOTICE INVITING TENDER**

The Executive Engineer (E) B.S.N.L., Electrical, Division, 1st Floor Block No. 35 SDA complex, Kasumpti, Shimla (HP) pin 171009 invites on behalf of Bharat Sanchar Nigam Limited sealed item rate tenders for the work from the eligible contractors satisfying the following conditions as given below :-

A) Eligibility Conditions

**The Contractors satisfying the following conditions: -**

- ❖ The Average annual turnover during last 3 years, Ending 31st March of previous financial year should be at least **Rs.29,904/-**.

**And**

- ❖ The Manufacturer/authorized dealer/OEM of batteries. The letter of authorization from manufacturer in original / photocopy attested by BSNL Executive will be submitted.

**OR**

- ❖ Experience of having successfully completed similar works (SITC/replacement of batteries) in BSNL during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following :-

- Three similar successfully completed works costing not less than the amount equal to **Rs.39,872/-**.

**OR**

- Two similar successfully completed works costing not less than the amount equal to **Rs.59,808/-**.

**OR**

- One similar successfully completed work costing not less than the amount equal to **Rs.79,744/-**.

**OR**

**BSNL enlisted contractors in Electrical category of class IV E and above**

The contractor shall also submit and confirm:

- i. Documentary proof of satisfying the eligibility conditions as per 1 above
- ii. CA certificate towards turn over /deposition of income tax & PAN Card
- iii. Himachal Pradesh GST registration certificate.

The contractor who are not registered under Himachal Pradesh GST may bid for the contract however such contractors will have to get himself registered within 15 days from the date of issue of intimation from BSNL regarding intent to accept the tender, else their EMD shall be forfeited absolutely and the firm shall not be allowed to participate in the next tender for the same work. The firm shall give an affidavit as per draft on page No. 5 in this regard.

- iv. EPF and ESI registration certificate.
- v. Service Tax registration certificate.
- vi. Declaration of EW-6 / EW-8, Relative Certificate & Undertaking -I & II by contractors
- vii. Tender Cost & EMD in prescribed form.

All the documents shall be self attested / certified by any BSNL/MTNL Executive /Notary /Gazetted Officer of Central Govt.)

Validity of tender shall be for 90 days from the date of opening of tender.

The tenders of contractors who do not deposit earnest money in the prescribed manner (in separate cover) are liable to be rejected and will not be opened.

The firm who quotes on the tender downloaded from web-site shall strictly follow the following Procedure:-

The tender shall be submitted in two envelope system.

i. First envelope shall contain tender application (If tender downloaded from Web), tender fee, attested documents (self attested and counter attested by any executive of BSNL/MTNL or Gazetted officer of GOI; otherwise all originals of eligibility criteria shall be produced for verification at the time of tender opening) proving fulfillment of eligibility criteria as per the tender notice & EMD in proper form. Separate D.D. should be attached for tender fee & EMD.

ii. Second envelope shall contain duly filled tender document.

The same shall be clearly written on the envelopes.

The 1st envelope containing Tender fee, attested documents proving fulfillment of eligibility Criteria & EMD in proper form shall be opened first..

In case: -

(i) Tender fee is not submitted in proper form. (ii) EMD is not in proper form.

(iii) Firm fails to fulfill eligibility criteria on the basis of document submitted in first envelop.

(iv) The performance of tenderer is not found satisfactory.

The second envelope shall not be opened.

If the day of opening of the tender declared as a Holiday then the tender will be opened on the next working day. The tenders shall neither be issued nor received through POST / COURIER. CONDITIONAL TENDERS OR TENDERS WITH CONDITIONAL REBATES SHALL BE SUMMARILY REJECTED. If any difference/ discrepancies found between down loaded Tender form, any hard copy issued from Division Office, the contents in Draft NIT issued from this or higher offices will be final & binding.
