2. Part -A TERMS AND CONDITIONS OF TENDER

Wax/PVC tape sealed Open tenders are invited on behalf of BSNL from experienced Contractors / agencies for Housekeeping/ Maintenance of IQ at Kullu, Manali & Holiday Home at Kullu., in Mandi SSA for one year or till the next tender is finalized with terms and conditions as under: -

1.The tenderer should submit following documents with tender. Last date/Time for receipt of tenders is 13:00 hours on or before date 15-02-2016. Tenders duly completed in all respects should be addressed to DE (CFA) O/o GMTD Mandi and shall be opened at 15:00 hours on the same day in presence of tenderers who may wish to be present. The tenderers are requested to divide the tender form into two parts as qualifying bid in one envelop (duly sealed & marked as Qualifying Bid) consisting the document establishing the eligibility as mentioned below (I) to (VI) and another envelope containing financial bid (Part D). Both aforementioned sealed envelopes should be kept in a outer cover (duly sealed & marked as "Tender for Housekeeping/ Maintenance of IQ"

- i.) Experience Certificate of previous job in BSNL/ MTNL/ Govt/Semi Govt/ PSUs for one third amount of tender value during the last three financial years (ie not current financial year and last three financial years). The certificate is to be signed by DGM/DE level officer or equivalent.
- ii.) Duly attested affidavit for Sole Prop/ Power of attorney in case firm is partnership concern along with copy of deed..
- iii.) EMD as stated in NIT.
- iv.) Declaration as per Part-C.
- v.) Signed copy of the tender terms & conditions
- vi.) PAN Card (Attach duly attested proof)
- vii Copy of Service Tax Registration No., if applicable or affidavit indicating reason for non-submission (attach proof).
- viii) Registration/Allotment number of-EPF (Attach duly attested proof) or affidavit indicating reasons for non-submission. Any other social security scheme for workers: (Like Group Insurance/personal accident insurance) (Give details) or affidavit indicating reason for non-submission.

Note:- Reasons of non-submission of document as per clause 1.(vii) & (viii) above should be in the form of Affidavit on non-judicial stamp paper. Reasons indicated should be convincing to the tender accepting authority.

- 2. The persons supplied on the above services should be less than 45 years of age and medically fit, neat and clean. Quoted rates shall be valid for 150 days from opening the bids.
- 3. The persons deployed should have experience of Maintenance and up keep of Holiday Home / IQ. If the person remains absent, the contractor will arrange substitute in advance, failing which proportionate amount will be deducted from the security deposit.
- 4. The BSNL will not in any case be liable for providing employment or other facility given to the BSNL employees, in respect of persons employed by the contractor at any time.

- 5. The contractor should comply with the entire dispute, regarding EPF /Labour which arises between contractor and persons deployed.
- 6. All legal obligations like payment of EPF/ ESI/ Workmen compensation shall be the responsibility of the contractor and shall keep BSNL indemnified against any Such claims made. The contractor must abide by all laws regarding employment of Labourers.
- 7. The BSNL will not be responsible for any dispute, which arises between contractor and persons employed by the contractor.
- 8. The payment of the bill duly verified by the controlling officer would be made on monthly basis after the same is submitted complete in all respect in the O/o GMTD Mandi subject to fulfillment of all statutory rules governing the contract.
- 9. Income Tax as applicable from time to time prescribed by the BSNL shall be recovered from contractor's bill.
- 10. The contractor will pay wages to the employees at the rate not less than the minimum wages as notified from time to time by the Centre Government.
- 11. If there is any dispute of any kind in interpretation of the clauses in terms and conditions of the contract, the matter will be referred to GMTD Mandi whose decision will be final and binding on both the parties.
- 12. GMTD Mandi reserves the right to terminate the agreement at any time without any reason, by giving one month's notice.
- 13. The successful tenderer has to deposit security of 10% of approved tender cost. The EMD deposited will be converted to security deposit and the remaining amount will be paid in the form of FDR dully pledged(details with SDE MIS O/o GMTD Mandi)/ bank draft drawn in favour of Accounts Officer (Cash) O/o GMTD Mandi.
- 14. If there is any damage to the property of Holiday Home / IQ the cost of the damaged property will be deducted from the security deposit and bills of the contractor at the rate of original cost of items damaged. Similarly penalty @ 5% of amount of bill payable to contractor shall be imposed in case of improper services rendered and complaints lodged by in charge of Holiday Home/users.
- 15. For proper up keeping of the Holiday Home/IQ the contractor has to report to incharge of Holiday Home/IQ daily for carrying out the instructions.
- 16. The successful tenderer shall have to enter into an agreement with BSNL for satisfactory implementation of job and rates shall remain in force for one year from date of agreement. The period can be extended by mutual agreement till new tenders are finalized.
- 17. GMTD Mandi reserves the right to reject any / all tenders without assigning any reasons.
- 18. Each tender should be accompanied with EMD of Rs 7500/- (Rs Seven thousand & five hundred only) in the form of Demand Draft/ BSNL Cash receipt drawn in favour of AO(Cash) O/o GMTD Mandi. The EMD is interest free.
- 19. The bidder shall enclose the signed copy of complete tender document at the time of submission along with the quoted rates in required format. In case of any correction in the rates mentioned in figures the rates quoted in words will be treated as final.
- 20. In case of non / late receipt of tender the responsibility rest with the bidder.
